	<p><b>Charges:</b> Sexual assault, FTC probation</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Court appearance from EMDC on Mar 14<sup>th</sup></li><li>• Released on a Form 11</li><li>• NFA</li><li>• Promise to pay \$1000 if FTC with release order</li><li>• Do not contact/communicate directly/indirectly with named party</li><li>• Do not be within 100m of any place of named party</li><li>• Do not possess any weapons as defined by the CCC</li><li>• Next court date is April 25<sup>th</sup></li></ul>

- Report to the John Howard Society as required
- Do not attend named addresses
- Do not possess any weapons as defined by the CCC
- Next court date is Apr 18<sup>th</sup>









**Charges:** Uttering counterfeit money, Possessing counterfeit money, Possession of property obtained by crime – under \$5000, Obstruct police, Possession of schedule I substance, Mischief, Possession of prohibited device or ammunition




**Released:**

- Promise to pay \$1000 if FTC with release order
- Report to the John Howard Society as required
- Do not attend named addresses
- Do not attend at any place where named party is
- Do not be within 25m of named party

- Next court date is April 18<sup>th</sup>

**Charge:** Assault with a weapon

**Disposition:**

- Court appearance on Mar 14<sup>th</sup>
- Criminal charge withdrawn
- Entered into a 12 months' peace bond
- Keep the peace and be of good behaviour generally and specifically towards named party



**Charges:** Assault with a weapon, FTC with probation x 3

**Disposition:**

- Court appearance on Mar 14<sup>th</sup>
- Found not criminally responsible after hearing
- Ontario Review Board to review and impose disposition



**Charge:** Theft over \$5000

**Disposition:**

- Court appearance on Mar 14<sup>th</sup>
- Guilty plea to theft under \$5000
- Absolute discharge
- Full restitution to victim



**Charges:** FTC release order x 2

**Disposition:**

- Court appearance on Mar 14<sup>th</sup>
- Guilty plea to FTC x 2
- 59 days of PSC - equal to 89 real days - global sentence of 95 days
- 12 months' Probation
- Do not possess any weapons as defined by the CCC
- DNA order



**Charge:** Theft under \$5000

**Disposition:**

- Court appearance on Mar 15<sup>th</sup>
- Guilty plea to theft under \$5000
- Suspended sentence
- 12 months' probation, usual conditions
- Do not attend named address



**Charge:** Assault with a weapon

**Disposition:**

- Court appearance on Mar 15<sup>th</sup>
- Guilty plea to assault with a weapon
- 12 months' probation
- 20 hours of community service
- No weapons



**Charges:** Break & enter  
Assault

**Disposition:**

- Court appearance on Mar 15<sup>th</sup>
- Break & enter charge withdrawn by the Crown – NRPC
- Next court date for the assault charge is April 19<sup>th</sup>





**Charge:** Impaired operation

**Disposition:**

- Court appearance on Mar 17<sup>th</sup>
- Guilty plea to Careless driving - HTA
- \$1500 fine
- 12 months' probation
- During the entire probation period, will have a blood alcohol concentration of zero at all times while driving, and will have a blood drug concentration of zero – except for lawfully prescribed drugs taken in accordance with a doctor's prescription – at all times while driving
- During the first 6 months of the order will not operate a motor vehicle except for the purposes of travelling directly to and from employment or schooling, or except while operating a motor vehicle as part of employment or schooling
- Take the Back on Track or similar remedial driving program as directed by probation
- Do not possess any non-prescription drugs or paraphernalia while operating a motor vehicle or in a motor vehicle that they are operating
- Attend and participate in any alcohol or substance abuse counselling or assessments as directed by probation
- Carry a copy of probation order with driver's licence at all times and surrender it to any peace officer who asks for driver's license.
- Criminal charge withdrawn as part of the resolution



	<p><b>Charge:</b> Sexual assault</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Court appearance on Mar 17<sup>th</sup></li> <li>• Agreed to a Peace Bond for 12 months</li> <li>• \$500 no deposit</li> <li>• Keep the peace and be of good behaviour</li> <li>• No contact or association, directly or indirectly of named party or their family</li> <li>• Not attend any known place of residence, employment, or education of named party or their family</li> <li>• Not to possess any weapons as defined by the CCC</li> <li>• Criminal charge withdrawn as part of the resolution</li> </ul>
	<p><b>Charges:</b> Possession of a weapon for a dangerous purpose, Assault with a weapon, Possession of a weapon for a dangerous purpose</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Court appearance on Mar 17<sup>th</sup></li> <li>• Agreed to 12 months' Peace Bond</li> <li>• \$1000.00 no deposit</li> <li>• No contact with named party</li> <li>• Do not attend within 25m of named party</li> <li>• Do not possess any weapons as defined by the CCC</li> <li>• All criminal charges for this incident were withdrawn as part of the resolution</li> </ul>
