Charges: Assault, Mischief under \$5000

#### Released:

- Bail hearing from STPS cells on Mar 18<sup>th</sup>
- Released on a Form 11
- NFΔ
- Pay \$200 if FTC with release order
- Next court date is March 28th



**Charges:** Assault x 2

#### Released:

- Bail hearing on Mar 20<sup>th</sup>
- Released on a Form 11
- Do not contact/communicate direct/indirect in any way with named parties
- Do not possess any weapons
- Next court date is March 28<sup>th</sup>



**Charges:** FTC with release order x 5, Theft using violence,
Possession of prohibited weapon without being holder of

licence x 3, Possess property obtained by crime \$5000,

Possess schedule I substance, trafficking x 2,

Possession of schedule I substance

#### Released:

- Court appearance on Mar 22<sup>nd</sup>
- Released on a Form 11
- Promise to pay \$500 if FTC with release order. Surety promises to pay \$1500
- Reside at named address
- Remain in residence or backyard of named address
- Do not contact/communicate direct/indirect by any means with named parties
- Do not attend named address
   Do not possess any weapons as defined by the CCC
- Remain in custody until a GPS monitoring device is available to be applied
- Next court date is April 24<sup>th</sup>



Charge: Mischief

#### Released:

- Bail hearing from STPS cells on Mar 23<sup>rd</sup>
- Released on a Form 11
- No financial obligation or conditions
- Next court date is April 25<sup>th</sup>



**Charge:** Theft under \$5000

#### **Disposition:**

- Court appearance from EMDC on Mar 23<sup>rd</sup>
- Released on a Form 11
- Do not attend named address.
- Next court date is Apr 11<sup>th</sup>

### **Dispositions:**



**Charges:** Theft under \$5000 x 4, FTC probation x 13, FTC with release order x 2, B&E x 3, Possession of property obtained by crime under \$5000 x 2

#### **Disposition:**

- Court appearance on Mar 21st
- Guilty plea to Theft under \$5000 x 5, Break and enter
- Sentenced to 171 days, 114 PSC, has 60 days remaining to serve at EMDC
- 2 years' probation, usual conditions
- Do not possess any tools used primarily for B&E
- Do not be within 25m or attend named addresses
- Do not possess any weapons as defined by the CCC
- Remaining charges withdrawn as part of resolution



**Charges:** Theft under \$5000, Use, deals, acts on forged document, Fraud under \$5000

#### **Disposition:**

- Court appearance on Mar 21st
- Guilty plea to Fraud under \$5000
- Suspended sentence
- 18 months' probation order, usual conditions
- Perform 40 hours of community service work within 11 months of the start of the probation order
- Make restitution of \$1840.00 to be paid within 17 months of the start of the probation order
- Remaining charges withdrawn as part of resolution



**Charges:** Theft under \$5000, Having liquor in open container in unauthorized place

#### **Disposition:**

- Court appearance from EMDC on Mar 21<sup>st</sup>
- Guilty plea to theft under \$5000
- Suspended sentence, plus 12 months' probation
- Usual conditions plus, re-connect with ACT team
- Do not attend any named address
