Sentenced to an additional 124 days• 2 years’ probation, usual conditions• No contact with named party• No weapons• 100 hours of community service• Remaining charges were either withdrawn or received a suspended sentence as part of resolution

	<p>Charges: Over 80 BAC, Disqualified driving, Possession schedule I substance – Crystal meth, Drive m/v with open alcohol - LLCA</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on April 13th• Guilty plea to Over 80 BAC and Disqualified driving• 30 days intermittent jail sentence• 2 years' driving prohibition• Remaining charges were withdrawn as part of resolution
	<p>Charges: Impaired operation, Fail to remain</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on April 14th• Guilty plea to Careless driving and Fail to report collision - HTA• \$1000 fine• 12 months' POA probation order• During entire probation period will have a BAC of zero at all times while driving• During the first 30 days of the order, will not operate a m/v except for purposes of travel directly to and from his place of education, employment or appointments• Complete remedial driving program through the MTO• Impaired operation charge withdrawn as part of resolution
