Will remain in custody until a GPS monitoring device is</li><li>• Original Form 11 release pending GPS install</li><li>• Promise to pay \$5000 if FTC with release order</li><li>• Reside with surety</li><li>• Remain in residence at all-time <b>EXCEPT</b>; medical or when in the presence of his surety</li><li>• Adhere to no contacts/communications list</li><li>• Do not seek, obtain or continue with any paid or unpaid activity that involves being in a position of trust or authority towards a person under the age of 16 years</li><li>• Do not attend a public park or public swimming pool where persons under the age of 16 years are present or can be expected unless in the direct company and supervision of surety</li><li>• No weapons as defined by the CCC</li><li>• Do not possess any cell phones, pager, digital device, or use any computers or any device that has access to the Internet except while in the company and supervision of surety or legal counsel</li><li>• Will be subject to GPS monitoring program and agree to all the rules/protocols</li><li>• Next court date is May 15<sup>th</sup></li></ul>

	<p><b>Charges:</b> APS – FTC undertaking, Assault x 5 OPP - Possess property over \$5000, FTC with release STPS – FTC with release order x 2</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on April 18<sup>th</sup></li><li>• Guilty plea to FTC with release, FTC undertaking, Assault</li><li>• Sentenced to 1 day deem served; 10 days PSC = 15 days</li><li>• 12 months' probation, usual conditions</li><li>• No contact/communication direct/indirect by any means with named parties</li><li>• Counselling for violence and alcohol</li><li>• No weapons</li><li>• DNA order</li><li>• Remaining criminal charges were withdrawn as part of the resolution</li></ul>

	<p><b>Charge:</b> Impaired Over 80 BAC</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on April 18<sup>th</sup></li><li>• Guilty plea to Over 80 BAC</li><li>• \$2000 fine</li><li>• 6 months probation, usual conditions</li><li>• Must attend, and actively participate in all assessments, counselling or rehab.</li><li>• 12 months driving prohibition</li></ul>
	<p><b>Charges:</b> Impaired driving, Over 80 BAC</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on April 18<sup>th</sup></li><li>• Guilty plea to Over 80</li><li>• \$2000 fine</li><li>• 12 months driving prohibition</li><li>• Remaining charge withdrawn as part of resolution</li></ul>
	<p><b>Charges:</b> Assault – Spousal, FTC release order x 6, Possession of prohibited device/ammo, Drive under suspension x 2, Possession of property over \$5000</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on April 18<sup>th</sup></li><li>• Guilty plea to Assault, FTC with release x 3, Drive under suspension - HTA</li><li>• Sentenced to time served</li><li>• Assault; 78 real days of custody equivalent to 117 days of enhanced custody</li><li>• FTC x 3; 60 days of enhanced custody</li><li>• \$1000 fine; Drive under suspension - HTA</li><li>• Probation for 18 months; usual conditions</li><li>• Do not to have any contact or communication with named parties</li><li>• Do not possess any weapons</li><li>• DNA</li><li>• S. 110 order for 5 years</li></ul>

	<p><b>Charges:</b> Possession of schedule I substance for purpose of trafficking x 5, Unauthorized possession of a weapon</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance from CNCC- Penetanguishene on April 19<sup>th</sup></li><li>• Guilty plea to one count; Possession for the purpose of trafficking – Fentanyl</li><li>• Sentenced to 1046 days minus pre-sentence custody time</li><li>• Remaining charges were withdrawn as part of the resolution</li><li>• Has outstanding charges before the court</li></ul>
	<p><b>Charge:</b> FTC with release order</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on April 20<sup>th</sup></li><li>• Guilty plea to FTC release order</li><li>• Suspended sentence</li><li>• 9 months' probation, usual conditions</li><li>• No contact/communication direct/indirect with named party</li><li>• Has remaining outstanding charges before the court</li><li>• Next court date is June 9<sup>th</sup></li></ul>
	<p><b>Charges:</b> Possess property obtained by crime under \$5000, Use, deals, acts on forged document</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on April 20<sup>th</sup></li><li>• Guilty plea to Utter forged document</li><li>• 12 months' probation</li><li>• 25 hours of community service</li><li>• Take any counselling treatment as directed</li><li>• Do not attend named address</li></ul>



**Charges:** Possession of schedule I substance for the purpose of trafficking – Meth, Opioids x 2  
Impaired operation, Prohibited driving CCC  
Drive under suspension - HTA

**Disposition:**

- Court appearance from Sarnia jail on April 21<sup>st</sup>
- All charges were withdrawn by the Crown – NRPC
- Has numerous outstanding criminal charges before the court
- Was released on a Form 11 from Sarnia jail on April 21<sup>st</sup>.
- Has warrants from London PS and STPS
