	<p>Charges: Use of credit card, Theft under \$5000, FTC probation</p> <p>Released:</p> <ul style="list-style-type: none">• Court appearance from STPS cells on Mar 30th• Released on a Form 11• Promise to pay \$500 if FTC with release order• Report to the John Howard as required• Do not contact/communicate in any way direct/indirect by any means with named party• Do not named addresses• DO not possess any ID, card with data strip, security strip, credit or debit card, blank card with a magnetic strip, negotiable banking document unless proven to be theirs• Next court date is April 18th
	<p>Charges: FTC with release order x 2, Assault police x 5, Resist police, Assault, Break and enter, FTC undertaking</p> <p>Released:</p> <ul style="list-style-type: none">• Court appearance from STPS cells on Mar 30th• Reside at named address• Remain in residence daily between 10pm and 6am except when in the presence of surety• Do not contact/communicate in any way direct/indirect by any means with named parties• WRC filed in advance with STPS• Do not attend within 25 of named address• No weapons• Next court date is April 5th

	<p>Charges: Assault x 3, FTC with undertaking x 6, Forcible confinement, FTC with release order x 7</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on Mar 28th• Guilty plea to FTC x 3• 1 day deemed served - 6 days enhanced at a 1.5:1 basis = 9 days• 18 months' Probation• No contact with named party except with consent of probation• Non-attendance within 25 meters of any known place of residence, employment or education of named party except consent of probation• No weapons• DNA order• All remaining criminal charges withdrawn as part of the global resolution
	<p>Charges: Assault, Fail to leave premises - TTPS</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on Mar 28th• Guilty plea to assault• Sentenced to time served, 25 days PSC enhanced to 1.5:1 = 38 days PSC• Remaining TTPA charge withdrawn as part of resolution
	<p>Charges: FTC with probation order x 3, Assault with a weapon</p> <p>Disposition:</p> <ul style="list-style-type: none">• All criminal charges were withdrawn• Found Not Criminally Responsible after hearing• Ontario Review Board to review and impose disposition

	<p>Charges: Mischief under \$5000</p> <p>Disposition:</p> <ul style="list-style-type: none"> • Court appearance on Mar 28th • Guilty plea to Mischief under \$5000 • 12 months' Probation, usual conditions • Perform 10 hours of community service within 11 months, work on a rate and schedule to be directed by Probation
	<p>Charges: Use credit card obtained by crime, Possession of property Under \$5000</p> <p>Disposition:</p> <ul style="list-style-type: none"> • Trial on March 29th • Found not guilty on all charges • Has unrelated outstanding criminal charges currently before the court
	<p>Charges: Possession of schedule I substance for the purpose of Trafficking – Meth Possession of schedule I substance for the purpose of Trafficking – Opioid</p> <p>Disposition:</p> <ul style="list-style-type: none"> • Court appearance on Mar 27th • Both CDSA charges withdrawn for the Crown – no reason • Has outstanding criminal charges before the court Awaiting sentencing
