	<p><b>Charges:</b> Sexual assault, Mischief, Resist police</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing on May 11<sup>th</sup></li><li>• Released on a Form 11</li><li>• Promise to pay \$500 if FTC with release order</li><li>• Do not contact/communicate with named party</li><li>• Do not be within 50m of named party</li><li>• Do not possess any weapons</li><li>• Next court date is May 23<sup>rd</sup></li></ul>
	<p><b>Charges:</b> -APS- Assault -STPS-Assault, Theft under \$5000</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing on May 11<sup>th</sup></li><li>• Released on a Form 11</li><li>• Promise to pay \$500 if FTC with release order</li><li>• Do not contact/communicate in any way with named parties</li><li>• Do not attend named address</li><li>• Do not be within 5m of named party</li><li>• Do not possess any weapons</li><li>• Next court date is May 16<sup>th</sup></li><li>• FTA court on May 16<sup>th</sup> – <b>BENCH WARRANT ISSUED</b> -</li></ul>

**Released:**

- Released on a Form 11
- Promise to pay \$750 if FTC with release order
- Report to the John Howard Society
- Do not contact/communicate in any way with named parties
- Do not attend all named addresses
- Do not possess ID or banking information unless proven to be lawful theirs
- Next court date is May 30<sup>th</sup>









**Charges:** Assault, Mischief, Possession schedule I substance - Opioid

- Released on a Form 11
- Promise to pay \$200 if FTC with release order
- Do not attend within 25m of named address
- Do not possess any weapons
- Next court date is June 19<sup>th</sup>

	<p><b>Charges:</b> -<b>OPP</b>- Criminal harassment, FTC undertaking x 2 -<b>STPS</b>- Assault, FTC undertaking, Mischief under \$5000</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on May 9<sup>th</sup></li><li>• Guilty plea to interference with lawful use of property and FTC undertaking x 1</li><li>• 18 months' probation</li><li>• No contact with named parties</li><li>• Non-attend any known place named parties</li><li>• Non-attend named address</li><li>• No weapons during probation</li><li>• Remaining charges were withdrawn as part of resolution</li></ul>
	<p><b>Charge:</b> Assault</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on May 9<sup>th</sup></li><li>• Assault charge withdrawn</li><li>• CLPB for 12 months</li><li>• Not to contact or communicate named parties</li><li>• Non-attend within 100m of any known place the named parties</li><li>• Do not possess any weapons</li></ul>
	<p><b>Charges:</b> B&amp;E x 5, FTC probation x 8, Mischief under \$5000 x 2, Theft under \$5000, Possession property under \$5000, Trespass/Prowl at night, Possession schedule 1 - Meth</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on May 9<sup>th</sup></li><li>• Guilty pleas to Theft under \$5000, B&amp;E x 4, FTC probation, Trespass at night, Mischief under \$5000</li><li>• Sentenced to 442 days custody, 194 pre sentence custody days served, has 248 left to serve</li><li>• 18 months' probation, usual conditions</li><li>• Numerous non contact/communication</li><li>• Numerous do not attend addresses upon his release</li><li>• Remaining charges were withdrawn as part of resolution</li></ul>

	<p><b>Charges:</b> -STPS- Trafficking property obtained by crime, Dangerous Operation, Flight from police, FTC x 3 -OPP-B&amp;E, Possess B&amp;E instruments, Theft under \$5000, FTC x 1</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on May 9<sup>th</sup></li><li>• Guilty pleas to Possession property under \$5000 obtained by crime, Dangerous driving, B&amp;E</li><li>• Suspended sentence for the possession of property under \$5000 obtained by crime</li><li>• 12 months custody for Dangerous driving</li><li>• Plus 45 days custody for the B&amp;E</li><li>• 24 months' probation, usual conditions</li><li>• 2 year driving prohibition</li><li>• DNA</li><li>• Remaining criminal charges were withdrawn as part of resolution</li></ul>
	<p><b>Charge:</b> Breach of conditional sentence order</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on May 10<sup>th</sup></li><li>• Found guilty of breach – sentenced varied</li><li>• Time served, spent 45 days in jail and was released to serve the remainder of the Conditional Sentence Order</li></ul>
	<p><b>Charges:</b> Breach probation, Theft under \$5000</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on May 10<sup>th</sup></li><li>• Charges withdrawn by the Crown</li><li>• No public interest</li></ul>

	<p><b>Charges:</b> Possess B&amp;E instruments x 2, B&amp;E, Possession of property obtained by crime under \$5000, Fraud under \$5000, Use, deals, acts on forged document, FTC undertaking x 2, Obstruct police, FTC release order x 2, Theft under \$5000</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Court appearance on May 10<sup>th</sup></li> <li>• Guilty pleas to B&amp;E, FTC undertaking, Obstruct police, FTC release order</li> <li>• Sentenced to time served, 40 days PSC</li> <li>• 12 months' probation, numerous conditions</li> <li>• Notify probation of an address</li> <li>• For the first 6 months remain in residence or on the property of his residence at all-times between the hours of 12am – 6am</li> <li>• Do not attend named addresses</li> <li>• Do not have in possession any financial instruments unless lawfully issued</li> <li>• Do not possess any instruments suitable for B&amp;E between sunset and sundown. This applies only when outside residence</li> </ul>
	<p><b>Charges:</b> Child pornography – Make available, Distribute, Sell, Import, Export, Advertise x 2 Child pornography – Possession x 2 Obstruct/Resist police, FTC probation, Mischief under \$5000, Possession schedule I substance - Meth</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Court appearance on May 11<sup>th</sup> for sentencing</li> <li>• Dec 7<sup>th</sup>, 2022 was found guilty; Child pornography – (Make available, Distribute, Sell, Import, Export, Advertise x 2)</li> <li>• Oct 3<sup>rd</sup>, 2022 entered guilty pleas to; FTC with Internet Prohibition order, Obstruct/resist police, Mischief under \$5000</li> <li>• Was sentenced to 6 years penitentiary (less 29 months enhanced to 43.5 months and credit of 4 months) leaving 24.5 months to serve</li> <li>• DNA</li> <li>• SOIRA order for 20 years</li> <li>• Lifetime 161 order</li> </ul>

- Extra judicial sanction (EJS) completed
- Charge withdrawn



**Charge:** Sexual assault (YOUTH)

**Disposition:**

- Court appearance on May 17<sup>th</sup>
- EJS completed
- 12 months' CLPB
- Do not contact/communicate in any way with named parties
- Do not be within 25m of named parties
- Charge withdrawn



**Charges:** Utter death threats, Assault, Firearms hearing

**Disposition:**



- Court appearance on May 19<sup>th</sup>
- Charges withdrawn by the Crown – NRPC



**Charges:** Impaired operation over 80 BAC, Careless Driving

**Disposition:**

- Court appearance on May 19<sup>th</sup>
- Over 80 BAC withdrawn by the Crown
- Guilty plea to Careless driving
- 1500 fine
- 12 months' probation order
- During the entire probation period BAC of zero while driving
- During the first 30 days of the order, will not to operate a motor vehicle, except for the purposes of travelling directly to and from place of employment or education, or directly to and from any previously scheduled appointment needed to comply with order
- During the first 30 days of the order will have an ignition interlock device installed in vehicle
- For the remaining 11 months of the order will not operate a motor vehicle except personal motor vehicle with a properly installed and operating ignition interlock device or a commercial motor vehicle in the course of employment
- Remedial driving program
- Carry a copy of probation order with driver's licence at all times and surrender it to any peace officer who asks for it.
- Attend and participate in any alcohol or substance abuse counselling as directed by your probation officer

	<p><b>Charges:</b> -<b>OPP</b>- Utter death threats  -<b>STPS</b>- Theft under \$5000 x 2, Escape lawful custody,  Possess property obtained by crime under \$5000 x 2,  Utter forged document, FTC undertaking</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Court appearance on May 19<sup>th</sup></li> <li>• Guilty plea to Possession of property obtained by crime under \$5000 x 1, Utter forged document, Theft under \$5000</li> <li>• 12 months' probation</li> <li>• Do not contact names parties</li> <li>• Non-attend any known place of named parties</li> <li>• Non-attend named addresses</li> <li>• Counselling as directed</li> <li>• Not to possess cheques, ID, credit/debit, etc. unless lawfully issued in your name</li> </ul>
	<p><b>Charges:</b> -<b>STPS</b>-  Mischief under \$5000 – Domestic, FTC undertaking x 2  -<b>OPP</b>-  FTC undertaking x 2</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Court appearance on May 19<sup>th</sup></li> <li>• Guilty plea to FTC undertaking x 1</li> <li>• Conditional discharge</li> <li>• 12 months' probation, usual conditions</li> <li>• No communication/contact with named parties</li> <li>• Non-attendance at any known place of residence, employment or education of named parties.</li> <li>• Pay restitution of \$50 to the Clerk of the Court</li> <li>• No weapons</li> </ul>
