	<p>Charges: Impaired operation, Over 80 BAC, Suspend drive – HTA</p> <p>Disposition:</p> <ul style="list-style-type: none"> • Court appearance on June 6th • Guilty plea to Careless driving • 1,000 fine • 12 months’ probation usual conditions • Zero BAC during entire probation • During the first 30 days of the order, must have ignition interlock installed in his personal m/v • Take remedial driving through the Ministry of Transport or MADD • Carry a copy of probation order with driver’s license and surrender it to an officer who asks • Remaining charges withdrawn as part of resolution

	<p>Charges: Assault x 2, Mischief under \$5000 x 2</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on June 6th• All criminal charges were withdrawn• Entered into a 9 month peace bond• No contact/communication direct/indirect with named parties• Do not attend any known residence, employment, or education of the above mentioned• Do not possess any weapons
	<p>Charges: Assault – Spousal x 3, Mischief – Domestic x 2, Assault with a weapon</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on June 6th• All criminal charges were withdrawn by the Crown• Entered into a 12 months’ common-law peace bond• Keep the peace especially towards named party• Do not possess any weapons
	<p>Charges: Impaired operation, Over 80 BAC, Fraud under \$5000</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on June 6th• Guilty plea to careless driving• \$1000 fine and 12 months’ probation - POA• During the entire probation period will have a blood alcohol concentration of zero at all times while driving, and will have a blood drug concentration of zero – exception prescription meds• Driving stipulations for first six months of the probation order• Take remedial drive program through the Ministry of Transportation or MADD• Do not possess any non-prescription drugs or paraphernalia while operating a motor vehicle• Carry a copy of the probation order with driver’s license and surrender it to any peace officer who requests it• Remaining charges withdrawn

	<p>Charges: Disqualified driving, plus numerous HTA offences</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on June 6th• Guilty plea to Disqualified driving• 90 days conditional sentence; on house arrest for the entire 90 days• Reside at named address• Permitted to leave residence every Friday b/w 8am – 9am solely for acquiring the necessities of life• Do not purchase, possess or consume alcohol or cannabis or any other intoxicating substances• Do not have care or control of a m/v• Remaining HTA charges were withdrawn

	<p>Charge: Theft under \$5000</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on June 6th• Charge withdrawn• Not in the public interest - NPI

	<p>Charges: Possession of weapons for a dangerous purpose, Knowledge of unauthorized possession of a weapon, FTC probation x 5, Possess property under \$5000</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on June 6th• Guilty plea to Possess property obtained by crime under \$5000• Sentenced to 30 days; 20 days of PSC• No contact with named parties• Remaining charges withdrawn as part of resolution• Has other matters before the court



Charges: -APS- Use forged document

Disposition:

- Court appearance on June 6th
- Guilty plea to Theft under \$5000, FTC, Use forged document
- 80 day global sentence - to be served intermittently
- 12 months' non-reporting probation
- No contact named party
- Do not attend named address
- Not to possess credit/debit card, ID, cheque, etc. unless in own name
- Remaining charges were withdrawn as part of resolution



Charges: Assault police x 4, Resist police x 2, FTC probation

Disposition:

- Court appearance on June 7th
- Guilty plea to assault police, and assault
- 37 days custody (PSC) enhanced to 56 days
- 24 months' probation with conditions
- Do not have any contact with named parties
- Do not attend at any known place or residence of named party
- No weapons 10 years
- DNA
- Remaining charges were withdrawn as part of resolution



Charge: Assault

Charge: Indecent assault on a female

- Found guilty as charged after trial on June 7th and 8th
- Suspended sentence
- 36 months' probation
- No contact with named party
- Do not attend at any known place of residence, employment or education of named party
