Charges: Possession of schedule I substance, FTC probation x 4, Possess property obtained by crime under \$5000 x 4, Theft under \$5000, Trespass at night, B&E

Released:

- Bail hearing from STPS cells on June 9th
- Released on a Form 11
- Promise to pay \$500 if FTC with release order
- Reside at named address
- Remain in residence daily b/w 10pm and 6am
- Do not contact/communicate direct/indirect by any means with named parties
- Do not be within 25m of named parties
- Do not attend named locations

- Remain in custody until a GPS device is placed on

- Do not contact or communicate with named party
- Remain 100m away from all named locations
- Remaining charges were withdrawn as part of the resolution



Charge: Fraud over \$5000

- Court date June 13th
- Guilty plea to Fraud over \$5000
- Suspended Sentence
- 2 years' Probation
- \$5000 restitution paid up front, make \$7,000 in restitution within the period of Probation
- Stand-alone restitution order

Knowledge of unauthorized possession of weapon, Possession of property obtained by crime under \$5000 x 15, FTC with release

FTC release order, B&E, Possess B&E tools, Possession of property under \$5000

Disposition:

- FTC probation x 2 were withdrawn
- Has numerous other criminal matters before the court



Charges: Disobey court order, Poss property obtained by crime Under \$5000 x 2, FTC release order x 3, Theft under \$5000, FTC probation, Fraud under \$5000

Disposition:

- Court appearance on June 15th
- Guilty pleas to Disobey court order, Poss property obtained by crime under \$5000, FTC release, Theft under \$5000, Fraud under \$5000
- Sentenced to 90 day global sentence imposed on all offences to date
 PSC of 37 days applied enhanced to 55 days - 35 days left to
- Non-reporting Probation to remain away from named locations
- Remains in custody on outstanding charges



Charge: Assault

- Do not possess any weapons



Charge: Mischief

- Court appearance on June 16th
 Charge withdrawn
 Entered into 12 months' peace bond recognizance
 \$500.00 no deposit if FTC with the Recognizance
 Do not contact/communicate in any way direct/indirect by any means with named party
