

# **COURT DISPOSITIONS**

## **Released:**



Charges: Assault, Utter threats BH

- Bail hearing from STPS cells on June 24<sup>th</sup>
- Released on a Form 11
- Promise to pay \$250 if FTC with release order
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not be within 25m of any place of named party
- Do not possess any weapons
- Next court appearance is July 11<sup>th</sup>



Charges: Assault with a weapon, Utter threats – BH, Prowl at night, Unlawfully in a dwelling, Criminal harassment x 2, Harassing communication, FTC release order x 2, FTC Undertaking x 2

#### Released:

- Bail hearing from EMDC on June 26<sup>th</sup>
- Released on a Form 11
- Promise to pay \$2000 if FTC with release order
- Reside with surety
- Remain in and on the property of residence 24 hours a day except 20 mins per day to walk dog, when in the presence of surety, to and from prescheduled apt with counsel, and medical emergencies
- Do not contact/communicate in any way direct/indirect by any means named parties
- Do not be within 500m of any place where known parties are
- Do not attend within 25m of named parties
- Do not associate or communicate in any way direct/indirect by any means with named parties
- Do not possess any weapons
- Remain in custody until a GPS is installed on the person and be amendable to the rules of the device
- Next court date is July 11<sup>th</sup>



**Charges:** Assault with a weapon, Unlawfully in a dwelling, Criminal harassment, FTC release order x 2, Possess prohibited weapon x 2, Assault

- Bail hearing on June 27<sup>th</sup>
- Released on a Form 11
- Promise to pay \$500 if FTC with release order
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not be within 100m of any place where named parties live, work, or go to school
- Do not possess any weapons
- Next court date is July 18<sup>th</sup>



**Charges: -STPS-**Assault, B&E x 2, Fraud, Use forged document, Possess Property under \$5000

- Bail hearing on June 27<sup>th</sup>
- Released on a Form 11
- Promise to pay \$500 if FTC with release order
- Report to the John Howard Society as directed
- Do not contact/communicate in any way direct/indirect by any Means with named party.
- Do not attend any known place or residence, employment, or education for the above mentioned people incl. named addresses
- Do not possess any weapons
- Do not possess any ID banks cards, cheques or bank document unless he can prove that t was lawfully issued
- Next court date is July 11<sup>th</sup>

## **Charges: -OPP Central Elgin-**

Possess property obtained by crime over \$5000 -STPS-

Trespass at night, FTC release order, Theft under \$5000 from m/v, B&E, Theft under \$5000 x 2, Possession of credit card, Use of credit card, Possess property obtained by crime under \$5000

- Bail hearing from EMDC on June 29<sup>th</sup>
- Released on a Form 11
- Promise to pay \$300 if FTC with release order
- Report to the John Howard Society as directed
- Reside at named address remain in residence b/w 8pm and 7am except for medical emergencies
- Do not contact/communicate direct/indirect by any means with named parties
- Do not attend any residential property in the city of St. Thomas **except** with the authorization of the occupant or home owner
- Do not possess any weapons
- Do not occupy the driver's seat of any m/v
- Do not possess any ID, bank documents debit, credit, cheques unless proven to be lawfully issued
- Do not attend any LCBO in Ontario
- Do not possess any B&E instruments
- Next court date is July 11<sup>th</sup>

- Report to the John Howard Society as directed
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend within 5m of named address
- Do not possess any weapons
- Next court date is July 4<sup>th</sup>

## **Dispositions:**



**Charges:** Assault, Possess property obtained by crime under \$5000, FTC undertaking x 2, Theft under \$5000 x 2, Possess Prohibited device or ammo x 2, FTC release order x 2

- Court appearance on June 27<sup>th</sup>
- Guilty plea to FTC release order, Theft under \$5000 x 2, Unauthorized possession of a prohibited weapon, FTC undertaking, Assault, Possess property obtained by crime under \$5000
- Suspended sentence
- 18 months' probation
- Do not to go to named addresses
- Do not contact or communication with named party
- Do not attend within 50 meters of any place you knownamed party to live, work, go to school or that you know them to be
- Do not possess any weapons
- Remaining charges were withdrawn as part of the resolution
- Has other criminal matters remaining and was subsequently released on a Form 11
- Next court date is July 18<sup>th</sup> for the outstanding charges

**Charges:** Impaired over 80 BAC, FTC recognizance x 2 FTA court

#### **Disposition:**

- Court appearance on June 27<sup>th</sup>
- Guilty plea to Impaired over 80 BAC and FTA court
- \$2200 fine
- Remaining charges were withdrawn as part of the resolution



**Charges:** Mischief under \$5000 x 2, FTC release order x 2

- Court appearance on June 27<sup>th</sup>
- Guilty plea to Mischief under \$5000 and FTC release order
- Time served 30 days custody (credit for 1 day of PSC)
- 12 months' probation
- Do not contact named paty except with written revocable consent –wrc- to be filed with Probation
- Do not attend at any place of residence, employment or education of named party
- Do not possess any weapons
- Remaining charges withdrawn as part of resolution
- Has other criminal matters before the court



**Charges:** Possess sched I substance – fentanyl, Possess sched I Substance – dilaudid, B7E, FTC release order

#### **Disposition:**

- Court appearance on June 27<sup>th</sup>
- Guilty plea to FTC, and B&E
- Time served, 60 days PSC enhanced to 90 days
- 12 months' probation
- Do not contact/communicate with named party
- Do not attend named address
- Remains in custody on outstanding charges



**Charges:** Fraud over \$5000 x 2, Adult forgery

- Court appearance on June 27<sup>th</sup>
- Guilty plea to Fraud over \$5000
- 12 month conditional sentence
- 12 months' probation
- Paid restitution
- For the first six months of the conditional sentence, obey a curfew to be in residence or on the property of residence 24 hours a day with exceptions for employment, counselling, medical emergencies and 4 hours per week (on a Friday) for the necessities of life, and attendance on Sundays for religious services
- For the last six months, obey a curfew from 11 pm to 6 am
- Remain in the Province of Ontario
- Not attend named addressses
- Make an additional payment of in restitution to to named party



Charges: Assault with a weapon, S. 810 Peace bond

- S. 810 hearing on June 30<sup>th</sup>
- Charge withdrawn by the Crown
- Entered into a 12 months' Peace Bond
- \$500, no deposit
- No contact named party
- Non-attend any known place of residence, employment or education of named party
- No weapons
