To be released on a Form 11 when GPS monitoring device is available</li> <li>• Promise to pay \$10,000 if FTC with release order</li> <li>• Reside with surety at named address</li> <li>• Obey a 24 hours curfew with exceptions</li> <li>• Do not contact/communicate in any way with named parties</li> <li>• Do not be within 100m where the named parties live, work, attend school</li> <li>• Do not be within 25m of the named parties</li> <li>• Do not possess any weapons</li> <li>• Do not possess a cell phone, pager, or personal digital assistant</li> <li>• Do not possess any substances named in the CDSA</li> <li>• Do not possess or consume any alcohol</li> <li>• Next court date is July 25<sup>th</sup></li> </ul>

	<p><b>Charges:</b> Assault – Spousal, Mischief - Domestic</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on July 11<sup>th</sup></li><li>• Guilty plea to assault</li><li>• Conditional discharge</li><li>• 12 months’ probation, usual conditions</li><li>• Do not contact/communicate in any way direct/indirect by any means with named party</li><li>• No weapons for 10 years</li><li>• DNA order</li><li>• Remaining charge was withdrawn as part of the resolution</li></ul>
	<p><b>Charges:</b> FTC release order x 5</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance at ECC on July 11<sup>th</sup></li><li>• Guilty plea to FTC x 1</li><li>• Sentenced to 60 days, time served – 40 days PSC</li><li>• DNA order</li><li>• Remains in custody on criminal matters from other police services</li></ul>

	<p><b>Charge:</b> Impaired operation Over 80 BAC</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on July 13<sup>th</sup></li><li>• Guilty plea to Over 80 BAC</li><li>• \$1500 fine</li><li>• 12 months' driving prohibition</li></ul>
