## **Released:**



**Charges:** Theft under \$5000 x 2

### Released:

- Bail hearing from STPS cells on July 1st
- Released on a Form 11
- Promise to pay \$200 if FTC with release order
- NFA
- Next court date is July 25<sup>th</sup>



**Charges:** Impaired operation cause death, Impaired operation cause bodily harm, Impaired operation

### Released:

- Bail hearing from STPS cells on July 5<sup>th</sup>
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Reside with surety at named address
- Do not have any contact/communication in any way direct/indirect by any means with named parties
- Do not attend any place the above mentioned live, work, attend school
- Do not operate or have care or control of a conveyance and not to occupy the seat ordinarily used by a driver of a conveyance
- Not to possess or consume alcohol
- Remain in Ontario
- Next court date is August 8<sup>th</sup>



**Charges:** Assault police x 3, Resist police x 2, Assault, FTC Undertaking, Utter threats – death to police officer

#### Released:

- Bail hearing from Care Facility
- Released on a Form 11
- Promise to pay \$1000 if FTC with release order
- Reside at named address and be amendable to the routine and discipline of the residence
- Remain in residence daily b/w 9pm 7am with exceptions
- Do not possess any weapons
- Next court date is August 2nd



**Charges:** Use, deals, acts on forged documents, Possession of Property obtained by crime under \$5000 x3, Theft Under \$5000, Fraud under \$5000

### **Released:**

- Bail hearing on July 5<sup>th</sup>
- Released on a Form 11
- Promise to pay \$500 if FTC with release order
- Report to the John Howard Society as directed
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not attend at any place the named parties live, work, attend school
- Do not attend within 25m of named addresses
- Next court date is July 25<sup>th</sup>



Charges: B&E, FTC probation order, FTC undertaking, FTC
Release order x 5, Obtain false pretence x 2, Possession
Property obtained by crime under \$5000 x 3, Use deals
Acts on forged document x 2, Possess another person's
Identity information, Possession of a credit card

### Released:

- Bail hearing from EMDC on July 7th
- Guilty plea to FTC release order x 1
- Released on previous Form 11 release order dated May 1, 2020
- Promise to pay \$500 if FTC with the release order
- Report to STPS every Monday
- Report to the John Howard Society as directed
- Notify STPS within 48 hours of any change in address
- Do not communicate direct/indirect with named parties
- Do not be within 50m of named address
- Do not attend at any place the named parties live, work, attend school

## **Dispositions:**



**Charges:** Mischief, FTC probation x 6, Use of credit card x 4, Possess property obtained by crime under \$5000, FTC release order x 2

### **Disposition:**

- Court appearance on July 4<sup>th</sup>
- Guilty plea to FTC probation, Mischief to property, Use credit card obtained by crime x 2
- Sentenced to time served; 120 days (80 days PSC = 120 days)
- 18 months' probation
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not possess any weapons



Charge: Assault

### **Disposition:**

- Court appearance on July 4<sup>th</sup>
- Charge withdrawn
- Entered into a 12 months' common law peace bond
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not be within 100m of any place where above mentioned lives, works or attends school
- Do not possess any weapons




Charges: FTC, Theft under \$5000, Disobey court order

### **Disposition:**

- Court appearance on July 4<sup>th</sup>
- Guilty plea to FTC probation, theft under \$5000
- Sentenced to 3 days (2 days PSC = 3 days)
- 12 month's probation, usual conditions
- Do not attend named addresses
- Remaining charges were withdrawn as part of the resolution
- Has unrelated charges currently before the court, next court date is July 18<sup>th</sup>

- Do not attend at any place where named party lives, works or goes to school
- Do not possess any weapons



**Charges:** Criminal harassment – engage in threatening conduct, Mischief over \$5000

### **Disposition:**

- Court on July 6<sup>th</sup>
- All charges were withdrawn by the Crown
