	<p><b>Charges:</b> Agreement to commit a sexual offence – under 18 years of age, Agreement to commit a sexual offence – under 16 years of age, Invitation to sexual touching – under 16 years of age, Makes, prints, publishes or possession for purpose, Child pornography, Possession child pornography</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing from EMDC on August 8<sup>th</sup></li><li>• Released on a Form 11</li><li>• Promise to pay \$2000 if FTC with release order</li><li>• Reside with surety at approved address</li><li>• Deposit all passports with STPS</li><li>• Do not contact/communicate direct/indirect in any way with all named parties</li><li>• Do not attend a public park, public swimming pool where persons under 16 years are present or can reasonably be expected to be present, daycares, school grounds, playground, community centre</li><li>• Do not seek, obtain or continue with any paid or unpaid activity that involves being in a position of trust or authority towards persons under the age of 16 years</li><li>• Do not possess any weapons</li><li>• Next court date is September 12<sup>th</sup></li></ul>

	<p><b>Charges:</b> FTC undertaking, Assault police x 2, Assault, Resist police x 2, ABH, Utter death threat</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing on August 9<sup>th</sup></li><li>• Released on a Form 11</li><li>• Promise to pay \$1000 if FTC with release order</li><li>• Reside with surety at approved address</li><li>• Remain in residence 9pm – 7am with exceptions</li><li>• Do not possess any weapons</li><li>• Do not possess, consume or purchase alcohol or intoxicating substances</li><li>• Attend an educational, vocational or work program by a local school board, place of learning and not be absent from the program except with written permission from surety</li><li>• Next court date is September 6<sup>th</sup></li></ul>
	<p><b>Charges:</b> Assault x 2, Forcible confinement, Utter threat to cause death, FTC release x 2</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing on August 10<sup>th</sup></li><li>• Released on a Form 11</li><li>• Promise to pay \$1000 if FTC with release order</li><li>• Reside at approved address</li><li>• Do not contact/communicate direct/indirect with named party</li><li>• Do not be within 25m of any place named party lives, works or attends school <b>except</b> court</li><li>• Do not attend within 25m of named address</li><li>• Do not possess any weapons</li><li>• Next court date is August 29<sup>th</sup></li></ul>

	<p><b>Charge:</b> Theft under \$5000</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on Aug 8<sup>th</sup></li><li>• Charge withdrawn</li><li>• DAP completed</li></ul>
	<p><b>Charges:</b> Theft under \$5000, Public mischief</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on August 8<sup>th</sup></li><li>• Guilty plea to theft under \$5000,</li><li>• Suspended sentence</li><li>• 12 months' Probation, usual conditions</li><li>• Do not attend named addresses</li><li>• Public mischief charge withdrawn</li><li>• Released from custody on previous undertaking with other criminal matters before the court</li></ul>
	<p><b>Charge:</b> Theft over \$5000</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on August 8<sup>th</sup></li><li>• Guilty plea</li><li>• Conditional discharge</li><li>• 12 months' Probation</li><li>• Non - association named parties</li><li>• Do not attend named address</li><li>• 23 hours Community Service</li></ul>

	<p><b>Charges:</b> Drive disqualified – CCC  Drive m/v no insurance – CAIA  Suspend drive, Drive m/v no permit - HTA</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Court appearance on August 8<sup>th</sup></li> <li>• Guilty plea to Disqualified drive</li> <li>• 60 day conditional sentence on house arrest</li> <li>• GPS monitoring; except for work, medical appointments and/or medical emergencies; once each week for necessities of life</li> <li>• Do not operate a motor vehicle with conditional sentence in effect</li> <li>• 12 months' Probation</li> <li>• Remaining charges withdrawn as part of resolution</li> </ul>
	<p><b>Charges:</b> Dangerous operation, Mischief, FTC undertaking x 2</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Trial on August 9<sup>th</sup></li> <li>• Acquitted of charges</li> </ul>
	<p><b>Charges:</b> Criminal harassment, S. 810 Peace Bond</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Court appearance on August 11<sup>th</sup></li> <li>• Charge withdrawn</li> <li>• Entered into a 12 months' Peace Bond</li> <li>• No contact/association direct/indirect with named party with exceptions including - WRC</li> <li>• Do not attend within 50m of any known place or residence, employment, or education of named party with exceptions including - WRC</li> <li>• Do not be within 25m of the named person except with – WRC</li> <li>• Changing Ways</li> <li>• No weapons</li> </ul>
	<p><b>Charges:</b> Assault with a weapon, S. 810 Peace Bond</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Court appearance on August 11<sup>th</sup></li> <li>• Charges withdrawn</li> <li>• Entered into a 12 months' Peace Bond</li> <li>• Do not contact/communicate direct/indirect with named party except with – WRC</li> <li>• Do not be within 25m of any known place of residence, employment or education of named party except with – WRC</li> <li>• Do not be within 5m of the named party except with – WRC</li> <li>• Do not possess any weapons</li> </ul>
