- Promise to pay \$1000 if FTC with release order
- Reside with surety
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not be within 5m of any place the named parties live, work, attend school
- Do not attend named addresses
- Do not possess any weapons
- Next court date is September 19<sup>th</sup>

**Charges:** Assault, Assault – Choking, Mischief under \$5000

**Disposition:**

- Court appearance on August 29<sup>th</sup>
- Guilty plea to assault
- Suspended sentence
- 12 months' Probation
- DNA sample
- S. 110 weapons prohibition
- Remaining charges withdrawn as part of the resolution



**Charges:** FTC release x 3

**Disposition:**

- Court appearance on August 29<sup>th</sup>
- Guilty plea to FTC x 1
- 60 days sentence, deemed served (40 days PSC enhanced to 60)
- Remaining charges withdrawn as part of resolution



**Charges:** Impaired operation, Over 80 BAC, Drive without proper headlights

**Disposition:**

- Court appearance on August 29<sup>th</sup>
- Guilty plea to Over 80 BAC
- \$2500 fine
- 1 year driving prohibition
- Remaining charges were withdrawn as part of resolution



**Charges:** Possession property obtained by crime under \$5000 x 3, FTC probation order

**Disposition:**

- Court appearance on August 29<sup>th</sup>
- All charges for this incident were withdrawn



**Charges:** Assault x 2

**Disposition:**

- Court appearance on August 29<sup>th</sup>
- Guilty plea to assault x 2
- Conditional discharge
- 12 months' Probation
- Do not contact/communicate direct/indirect by any means with named parties
- Do not be within 50m of any place the named party is known live, work, attend school
- Do not possess any weapons



**Charges:** Criminal harassment, Dangerous operation, Mischief under \$5000

**Disposition:**

- Court appearance on August 29<sup>th</sup>
- Charges withdrawn
- DAP completed
- Entered into a 12 months' CLPB
- No contact/communication direct/indirect by any means with named party



**Charges:** Possession of property obtained by crime under \$5000, Utter forged document

**Disposition:**

- Court appearance on August 29<sup>th</sup>
- Guilty plea to utter forged document
- 15 days sentence, (9 days PSC, deemed served)
- Remaining charges were withdrawn as part of resolution



**Charges:** Possess counterfeit money x 3, Unauthorized possession of a prohibited weapon x 2, Possession of a firearm prohibited weapon x 2, Possession for purpose trafficking x 2, FTC release order, Possess property under \$5000

**Disposition:**

- Court appearance on August 29<sup>th</sup>
- Guilty plea to Unauthorized possession of a prohibited weapon, Possess firearm, prohibited weapon
- 45 days PSC
- Remaining charges from this incident were withdrawn as part of a resolution
- Still has other unrelated matters



**Charges:** Theft under \$5000, Consume liquor in unauthorized place

- Charges withdrawn by the Crown

- Changing Ways completed
- Charge withdrawn by the Crown



**Charge:** Theft under \$5000

**Disposition:**

- Court appearance on August 29<sup>th</sup>
- DAP completed
- Charge withdrawn by the Crown



**Charges:** B&E, Possess B&E tools, Prohibited operation, Impaired operation, Trafficking stolen goods under \$5000, FTC release order, FTC undertaking Possess property obtained by crime under \$5000 x 2, Use of credit card, Assault – BH, Unlawfully in a dwelling, Forcible confinement, FTC Prob

**Disposition:**

- Court appearance on August 29<sup>th</sup>
- Guilty pleas to B&E, Impaired operation, Disqualified driving, FTC probation
- 188 days sentence (125 days PSC = 188 days) 1 day deemed served
- 2 years' Probation
- Do not contact/communicate in any way, direct/indirect by any means with named parties
- Do not be within 25m of any place where named parties are known to live, work, attend school
- Do not attend named addresses
- Do not possess any weapons
- Remaining charges withdrawn as part of resolution





**Charges: APS – B&E**

**Probation** – Assault with a weapon, Mischief under \$5000,  
Breach Probation

**Disposition:**

- Court appearance on August 29<sup>th</sup>
- Guilty plea to Assault, B&E, FTC
- 120 days jail (76 days enhanced to 114 days) 6 days remaining
- 18 months' Probation
- DNA



**Charges: Sexual assault, Sexual interference**

**Disposition:**

- Found guilty after trial January 2023
- Sentenced this date, August 30<sup>th</sup>
- 14 months jail sentence
- 12 months' Probation
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not be within 200m of any place named parties are known to live, work, attend school
- 10 years' weapons order
- 20 years SOIRA term



**Charges: Assault, S. 810 Peace Bond**

**Disposition:**

- Court appearance on September 1, 2023
- Charge withdrawn
- Entered into a 12 months' Peace Bond
- Do not contact/communicate or associate in any way direct/indirect by any means with named parties
- Do not attend named address
