	<p><b>Charges:</b> Possess for purpose of trafficking, FTC release order, Resist police, Operate conveyance while prohibited x 2, Operate conveyance dangerous x 2</p> <p><b>Released:</b></p> <ul style="list-style-type: none"> <li>• Bail hearing on September 13<sup>th</sup></li> <li>• Bail set, not met until GPS monitor is installed</li> <li>• Released on a Form 11</li> <li>• Promise to pay \$2000 if FTC with release order</li> <li>• Reside with surety at named address</li> <li>• Remain in residence daily b/w 10pm &amp; 6am with exceptions</li> <li>• Do not possess any weapons</li> <li>• Do not operate or have control of a m/v</li> <li>• Next court date is October 23<sup>rd</sup></li> </ul>
