Obtain false pretense x 2, Poss property obtained by crime

Obtain by false pretense

Released:

- Bail hearing on September 20th
- Promise to pay \$1000 if FTC with the release order
- Reside with surety at named address
- Remain in residence 24 hours a day with exceptions
- Do not contact/communicate in any way direct/indirect by any means named parties
- Do not be within 100m of any place where named party lives, works or attends school
- Do not attend numerous business in St. Thomas, Chatham, and London
- Do not possess any computer, printer, computer program, or any device capable of making ID's
- Do not possess any ID, card with strip, debit/credit or bank document unless it has been lawfully issued in name
- Next court date is October 24th

Charges: Possess schedule I substance – fentanyl, and crystal meth, Knowledge of unauthorized possession of weapon x 2, Possess property obtained by crime under \$5000 x 5, Possess counterfeit money x 3

Disposition:

- Court appearance on September 19th
- Guilty plea to aggravated assault – 3 year prison sentence
- Guilty pleas to the following: Theft of m/v, Drive disqualified, theft under \$5000, FTC release order x 4
- Global sentence of 7 years less time served including the STPS charge
- 7 year global sentence; 2520 days - credit for 25 months of PSC enhanced to 37.5 days (= to 1125 days) - leaving 1395 days to serve
- 2 years' driving prohibition
- No contact/communication with named party
- DNA order on applicable charges
- S. 109 Order for life
- Remaining charges withdrawn as part of the resolution

- Extra Judicial Sanctions (EJS) completed
- Sexual assault charges x 2 withdrawn by the Crown
- Entered into a 12 months' CLPB
- No contact/communication by any means with victims
