- Arrested on October 6th and remanded into custody

Charges: Assault x 2, FTC Probation x 5

Disposition:

- Court appearance on October 3rd
- Found Not Criminally Responsible – NRC
- Absolute discharge
- Joint recommendation, found unfit to stand trial; use of street drugs interferes with legitimate prescriptions; at high risk to re-offend a violent offence; mental health
- Non-association with three persons named nor attend at any place of residence, employment or education of those 3 persons;
- Do not possess any weapons
- Attend before the Ontario Review Board (ORB) within 45 days of Oct 3rd

Disposition:

- Court appearance on October 3rd
- DAP completed
- Charges withdrawn by the Crown



Charge: Impaired operation

Disposition:

- Court appearance on October 3rd
- Guilty plea
- \$1000 fine
- 12 months' driving prohibition



Charges: Theft under \$5000, FTC Probation, FTC release order, Possess property obtained by crime

Disposition:

- Court appearance on October 3rd
- Guilty pleas to; Theft under \$5000, FTC release, Breach Probation
- Sentenced to 30 days, time served
- 18 months' Probation
- Do not contact named parties
- Do not to be within 100m of any known place of residence, employment or education of named parties
- Has active charges before the court

- \$1300 fine
- 12 months' driving prohibition
- 10 days of PSC enhanced to 15 days
- 2 years' Probation
- Do not attend named addresses
- Do not contact/communicate with named party
- Do not possess any weapons, S. 110 Order; DNA
