Released:


- Bail hearing on September 27th
- Released on a Form 11
- Promise to pay \$1000 if FTC with release order
- Reside with surety
- Do not contact/communicate in any way direct/indirect by any means with list of named parties
- Do not be within 100m of any place where the named parties live, work, attend school, frequent, or any place they are known to be
- Do not be within 25m of the named parties **except** court appearances
- Do not possess any weapons
- Next court date is October 18th




Charges: FTC Probation x 4, Possess property obtained by crime x 4, B&E, Theft under \$5000, Trespass at night, Sexual assault

Released:

- Bail hearing on September 28th
- Released on a Form 11
- Subject to a GPS monitoring device
- Promise to pay \$1000 if FTC with release order
- Reside at named address
- Remain in residence 24 hours a day with exceptions
- Do not contact/communicate in any way direct/indirect by any means with the list of named parties
- Do not be within 100m of any place the named parties live, work, attend school or frequent
- Do not attend within 100m named address
- Do not possess any weapons
- Do not possess any ID, bank card, document unless he can prove it has been lawfully issued
- Next court date is November 7th

	<p>Charges: FTC Probation x 5, FTC – do not possess weapons x 2, Possess prohibited weapon x 2, Trafficking in stolen goods Under \$5000, Possess property obtained by crime under \$5000, Possess prohibited weapon – brass knuckles, Possess for the purpose of trafficking x 5</p> <p>Released:</p> <ul style="list-style-type: none"> • Bail hearing on September 28th • Released on a Form 11 • Promise to pay \$500 if FTC with release order • Report to the John Howard Society as directed • Do not contact/communicate in any way direct/indirect by any means with named party • Do not attend at named address • Do not possess any weapons • Next court date is October 23rd

- Suspended sentence on the remaining charges
- 2 years' Probation
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not be within 50m of any place the named parties live, work, attend school
- Do not be within 25m of the entire City block of named addresses
- Do not possess any ID, banking document, debit/credit card unless it has been lawfully issued

	<p>Charges: Assault x 3, Mischief, S. 810 Peace Bond</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on September 29th• Entered into a 12 months' Peace Bond• Do not contact/communicate with named parties• Do not to attend at any known place of residence, employment or education of named parties• No weapons• Charges were withdrawn as part of the resolution
	<p>Charges: Impaired operation, Over 80 BAC</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on September 29th• Plead guilty to lesser charge, Carless driving• \$2000 fine• 12 months' POA probation order• Complete back on track – remedial• Remaining charges were withdrawn as part of the resolution



Charges: Sexual assault, Invitation to sexual touching, Sexual interference

Disposition:

- Superior trial by Judge alone concluded on September 29th
- Was found not guilty on all charges
