## Released:


<ul> <li>Charges: ABH, Mischief – Domestic x 3, FTC x 2, Assault with a weapon – Spousal, Intimidation, Mischief</li> <li>Released: <ul> <li>Bail hearing on September 23<sup>rd</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$1250 if FTC with release order</li> <li>Do not contact/communicate in any way direct/indirect by any means with named party</li> <li>Do not be within 100m of any place where named party lives, works or goes to school, including named address</li> <li>Next court date is October 6<sup>th</sup></li> </ul> </li> </ul>
<ul> <li>Charges: Theft under \$5000 x 2, Assault, FTC Probation x 2</li> <li>Released: <ul> <li>Bail hearing on September 26<sup>th</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$500 is FTC with release order</li> <li>No contact/communication direct/indirect with named party</li> <li>Do not attend any known place of residence, employment, or education of named party</li> <li>Do not attend named addresses</li> <li>Do not possess any weapons</li> <li>Next court date is November 7<sup>th</sup></li> </ul> </li> </ul>

<ul> <li>Charges: Operation while impaired, FTC release order</li> <li>Released: <ul> <li>Bail hearing on September 27<sup>th</sup></li> <li>Released on a Form 11</li> <li>Next court date is October 24<sup>th</sup></li> </ul> </li> </ul>
<ul> <li>Charges: Mischief, Assault x 2, Unlawfully in a dwelling, Utter Threat, FTC undertaking, FTC Probation x 2</li> <li>Released: <ul> <li>Bail hearing on September 27<sup>th</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$1000 if FTC with release order</li> <li>Reside with surety</li> <li>Do not contact/communicate in any way direct/indirect by any means with list of named parties</li> <li>Do not be within 100m of any place where the named parties live, work, attend school, frequent, or any place they are known to be</li> <li>Do not be within 25m of the named parties except court appearances</li> <li>Do not possess any weapons</li> <li>Next court date is October 18<sup>th</sup></li> </ul> </li> </ul>
<ul> <li>Charges: FTC Probation x 4, Possess property obtained by crime x 4, B&amp;E, Theft under \$5000, Trespass at night, Sexual assault</li> <li>Released: <ul> <li>Bail hearing on September 28<sup>th</sup></li> <li>Released on a Form 11</li> <li>Subject to a GPS monitoring device</li> <li>Promise to pay \$1000 if FTC with release order</li> <li>Reside at named address</li> <li>Remain in residence 24 hours a day with exceptions</li> <li>Do not contact/communicate in any way direct/indirect by any means with the list of named parties</li> <li>Do not be within 100m of any place the named parties live, work, attend school or frequent</li> <li>Do not possess any weapons</li> <li>Do not possess any ID, bank card, document unless he can prove it has been lawfully issued</li> <li>Next court date is November 7<sup>th</sup></li> </ul> </li> </ul>


Charges: FTC Probation x 5, FTC – do not possess weapons x 2, Possess prohibited weapon x 2, Trafficking in stolen goods Under \$5000, Possess property obtained by crime under \$5000, Possess prohibited weapon – brass knuckles, Possess for the purpose of trafficking x 5
<ul> <li>Released:</li> <li>Bail hearing on September 28<sup>th</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$500 if FTC with release order</li> </ul>

• Do not contact/communicate in any way direct/indirect by any means with named party
• Do not attend at named address
• Do not possess any weapons
• Next court date is October 23 <sup>rd</sup>

Charge: Assault
<ul> <li>Disposition:</li> <li>Court appearance on September 25<sup>th</sup></li> <li>Charge withdrawn by the Crown</li> <li>No public interest - NPI</li> </ul>



<ul> <li>Charge: Possess property obtained by crime under \$5000</li> <li>Disposition: <ul> <li>Court appearance on September 26<sup>th</sup></li> <li>Charge withdrawn by the Crown</li> <li>NRPC</li> </ul> </li> </ul>
<ul> <li>Charges: Robbery with weapon, Theft under x 3, FTC release x 3, Possess property obtained by crime under \$5000 x 3, Use of credit card x 3, Trespass at night, FTC Probation</li> <li>Disposition: <ul> <li>Court appearance on September 27<sup>th</sup></li> <li>Guilty plea to robbery, FTC Probation, FTC release order x 2, Theft under \$5000 x 2, Trespass ant night, Use of credit card</li> <li>I day deemed served; 97 days PSC enhanced to 146 days – Only on the Robbery charge</li> <li>Suspended sentence on the remaining charges</li> <li>2 years' Probation</li> <li>Do not contact/communicate in any way direct/indirect by any means with named parties</li> <li>Do not be within 50m of any place the named parties live, work, attend school</li> <li>Do not be within 25m of the entire City block of named addresses</li> <li>Do not possess any ID, banking document, debit/credit card unless it has been lawfully issued</li> <li>DNA</li> <li>10 years' weapons prohibition order</li> <li>Remaining charges withdrawn as part of global resolution</li> </ul> </li> </ul>



Charges: Sexual assault, Invitation to sexual touching, Sexual interference Disposition: • Superior trial by Judge alone concluded on September 29 <sup>th</sup> • Was found not guilty on all charges
