	<p><b>Charges:</b> Unlawfully in a dwelling, Mischief under \$5000</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing on October 8<sup>th</sup></li><li>• Released on a Form 11</li><li>• Promise to pay \$200 if FTC with the release order</li><li>• Next court date is October 31<sup>st</sup></li></ul>
	<p><b>Charge:</b> FTC - Probation</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing on October 13<sup>th</sup></li><li>• Released on a Form 11</li><li>• Report to Probation as directed</li><li>• Next court date is October 17<sup>th</sup></li></ul>

	<p><b>Charge:</b> Assault</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing on October 13<sup>th</sup></li><li>• Released on a Form 11</li><li>• Promise to pay \$1000 if FTC with the release order</li><li>• Do not contact/communicate in any way direct/indirect by any means with named party</li><li>• Do not attend within 100m of any place named party lives, works, attends school except for court</li><li>• Do not be within 25m of named party</li><li>• Do not possess any weapons</li><li>• Next court date is November 21<sup>st</sup></li></ul>

	<p><b>Charges:</b> FTC Probation x 2, FTC undertaking, FTC release order, Assault</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on October 10<sup>th</sup></li><li>• Guilty pleas to; FTC release order, FTC undertaking</li><li>• 30 days sentence; time served</li><li>• 12 months' probation</li><li>• No contact/communication with named party, non-attendance at any known place of residence, employment or education of named party</li><li>• Do not possess any weapons</li><li>• Has remaining live matters before the court</li></ul>

**Charges:** -**OPP**- FTC undertaking, S. 810 Peace Bond  
-**STPS**- Sexual assault, Assault, S. 810 Peace Bond

**Disposition:**

- Court appearance on October 10<sup>th</sup>
- Entered into a 12 months' Peace Bond
- Charges were withdrawn by the Crown
- No contact/communication direct/indirect by any means with named party
- Do not attend within 100m of any known place of residence, employment or education of named party
- No weapons
- Provide proof of successful completion of Changing Ways to the STPS by the end of S. 810 peace bond order



**Charge:** Theft under \$5000

**Disposition:**

- Court appearance on October 10<sup>th</sup>
- DAP completed
- Charge withdrawn



**Charge:** Robbery

**Disposition:**

- Court appearance on October 10<sup>th</sup>
- Guilty plea to Robbery
- 120 days of PSC enhanced to 180 day sentence
- 2 years' Probation
- No contact/communication with named party, no exceptions
- Do not to attend any place of employment, education or residence of named party
- Do not possess any weapons
- 40 hours of community service
- DNA



**Charges:** Disobey court order, Possess property obtained by crime under \$5000 x 4, FTC Probation x 8, Use of credit card x 3, B&E x 2, Possess B&E tools, FTC release order x 4, Possess sched I substance – Meth, Posses forged document

**Disposition:**

- Court appearance on October 8<sup>th</sup>
- Guilty pleas to; Disobey court order, Use of credit card x 2 Possess property over \$5000 x 5 FTC Probation, B&E, FTC release order x 3 Theft from mail
- 150 days PSC enhanced to 225 days; time served
- 2 years' Probation
- Do not attend named addresses
- Do not contact/communication with named party
- Do not possess any credit/debit cards, ID cards or documents, cheques that are not in your name
- Remaining charges were withdrawn as part of global resolution



**Charges:** Theft under \$5000, B&E, Assault police, Assault, FTC

**Disposition:**

- Court appearance on October 8<sup>th</sup>
- Guilty pleas to; Assault police, FTC release order
- Conditional discharge
- Sentenced to time served, 5 days PSC
- 15 months' Probation
- Do not possess any weapons
- Remaining charges were withdrawn as part of the resolution



**Charges: - OPP –**

Theft under \$5000 x 2, Theft of m/v x 3, FTC release x 2, Assault police x 2, B&E x 2, Possess property under \$5000, Possess identification documents

**-STPS-**

FTC release order, Assault police x 5, Resist police, Assault, FTC undertaking, B&E, Mischief

**Disposition:**

- Court appearance on October 11<sup>th</sup>
- Time served
- 2 years' Probation
- No direct/indirect contact/communication with named parties
- Do not attend at any known place or residence, education or employment of the named parties
- Do not attend named locations
- Do not have possession any break in instruments
- Obey a curfew
- Do not have in your possession and ID document etc. that has not been lawfully issued
- Do not possess any weapons
