	<p><b>Charges:</b> Break and enter x 2, Mischief under \$5000, Breach Probation x 2</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing from STPS cells on October 15<sup>th</sup></li><li>• Released on a Form 11</li><li>• Promise to pay \$250 if FTC with the release order</li><li>• Do not contact/communicate in any way direct/indirect by any means with named party</li><li>• Do not attend within 25m of named address</li><li>• Next court date is November 7<sup>th</sup></li></ul>

**Charges:** Utter threats – Spousal, Forcible confinement, Assault – Spousal, Assault - Choke

**Released:**

- Promise to pay \$1000 if FTC with release order
- Reside with sureties at named address
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not be within 25m of named party
- Do not be in the Municipality of St. Thomas **except** for court or prescheduled appointments with legal counsel
- Do not be within 100m of any place named parties live, work or attend school **except** on one occasion to retrieve belongings
- Do not possess any weapons
- Next court appearance is November 21<sup>st</sup>

	<p><b>Charges:</b> Possess schedule I substance – Cocaine, Possess Schedule I substance - Fentanyl, Possess property obtained by over \$5000 Drive while under suspension, Drive m/v – no licence - HTA</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Trial on October 19<sup>th</sup></li><li>• Avoided a trial and plead guilty to Possession property obtained by crime over \$5000</li><li>• Conditional discharge</li><li>• 12 months' Probation</li><li>• Perform 40 hours of community service</li><li>• Do not occupy the driver's seat of any m/v during the duration of the order</li><li>• Remaining charges were withdrawn as part of the resolution</li></ul>
	<p><b>Charges:</b> Prohibited operation, Obstruct police</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on October 20<sup>th</sup></li><li>• Information &amp; warrant withdrawn by the crown</li><li>• No public interest</li></ul>

- 12 month duration
- No contact/association, directly/indirectly with named party
- Do not attend named address
- Do not possess any weapons
- Completed DAP
- Remaining charges were withdrawn



**Charges:** Criminal harassment – Repeated communication  
Criminal harassment – Besetting/Watching

**Disposition:**

- Trial scheduled for October 20<sup>th</sup>
- Avoided trial and entered into a 2 year CLPB
- Do not contact/communicate direct/indirect by any means with the named parties
- Do not be within 200m of named addresses
- Do not attend within 100m of named parties
- Charges were withdrawn
