Disposition:

- Remain 100m from named address
- Remaining charges were withdrawn as part of the resolution



Charge: Cruelty to animals

Disposition:

- Court appearance on November 7th
- DAP completed
- Charge withdrawn by the Crown



Charges: Robbery, Assault with a weapon

Disposition:

- Court appearance on November 7th
- Guilty plea to lesser charge of assault
- 4 months jail - 134 actual days, 1 day deemed served
- 3 years' Probation
- No contact with named party
- Do not attend any known place of residence, employment, or education of named party
- Do not possess any weapons
- DNA
- Held in custody for London PS on outstanding charges



Charge: Theft under \$5000

Disposition:

- Court appearance on November 7th
- DAP program completed
- Charge withdrawn



Charges: Impaired driving, Over 80 BAC – RCMP charges

Disposition:

- Court appearance on November 7th
- Occurrence transferred Sussex, New Brunswick RCMP to St. Thomas ECC for guilty plea
- Guilty plea to Over 80 BAC
- \$1200 fine
- 12 months' driving prohibition



Charges: Posses credit card obtained by crime x 5, Theft under \$5000, FTC Probation x 8

Disposition:

- Guilty plea to; Possess credit card obtained by crime
- Sentenced to 2 days of PSC enhanced to 3 days; 1 day deemed served
- All remaining charges were withdrawn by the Crown



Charges: B&E, FTC Probation

Disposition:

- Court appearance on November 8th
- Guilty plea to B&E
- 18 months' Probation
- ETC completed
- Live at named address
- Do not attend within 100m of named address Remaining charge withdrawn



Charge: Criminal harassment

Disposition:

- Court appearance on November 8th
- Entered into a 12 months' Common Law Peace Bond
- Charge withdrawn
- ETC Complete
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not be within 100m of any place the named parties live, work, attend school, or places they frequent
- Do not be within 25m of named parties
- Do not possess any weapons



Charges: Mischief – Domestic x 3, Assault with a weapon – Spousal, Utter death threats – Spousal x 2, Utter threats – Damage property, Criminal harassment

Disposition:

- Court appearance on November 8th
- Guilty pleas to; Mischief x 3, Utter death threat, lesser charge of assault
- Changing Ways completed
- Absolute discharge
- \$600 fine
- Remaining charges were withdrawn as part of the resolution



Charges: Possession of ammo 2, Possess schedule I substance x 2 Meth and Fentanyl

Disposition:

- Court appearance on November 8th
- Guilty plea to Possess ammo
- \$100 fine
- Forfeiture order for the ammo
- Weapons prohibition - lifetime
- Remaining charges were withdrawn as part of the resolution



Charge: Assault

Disposition:

- Court appearance on November 8th
- Guilty plea
- Conditional discharge
- 6 months' Probation
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend any place named party lives, works or goes to school
- Do not possess any weapons



Charges: Assault x 2 - Spousal

Disposition:

- Trial on November 9th
- Entered into a CLPB for 2 years avoiding a trial
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend within 100m of named party
- Do not attend any place named party lives, works or attends school
- Charge withdrawn as part of resolution



Charges : Robbery

Disposition :

- Robbery Charge withdrawn.
- 12 Month S. 810 Peace Bond imposed
- Do not contact/communicate with named party



Charges: Criminal Harassment, Fail to Comply with Release Order

Disposition: All charges withdrawn, Peace Bond resolution



Charges: Fail to Comply Probation x 7; Theft under x4, Fail to Comply Release Order x 2, Possess Property

Disposition :

- Guilty Plea to Theft Under STPS charge, Theft Under APS and one count of Failing to Comply with Probation, STPS charge. All other charges withdrawn.
- APS and STPS charges dealt with together
- 90 days custody. Was in jail 25 days, enhanced to 38, 52 days remaining in custody.
- Non reporting Probation Order



Charges:

Assault With a Weapon, Assault x 7, Threat to damage property, Fail to comply with release order x 3, Fail to Comply probation, Mischief to property and Fail to Stop.

Disposition:

- Guilty plea to one count of assault and one count of failing to comply with release order. All other charges were withdrawn
- Suspended Sentence. 12 month Probation



Charge: Impaired Operation

Disposition : Guilty plea to charged offence. \$3,000 fine and 24 month driving prohibition



HIGHAM, Brenden (29AUG88)

Charges: Unlawfully entering dwelling and mischief

Disposition:

- Guilty plea to mischief
- Conditional discharge. 18 months Probation

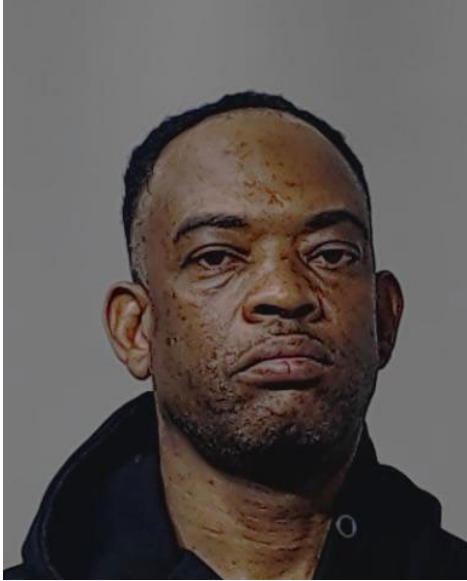


HORNE, Darryl (17APR83)

Charges: Possession Sched I drug (crystal meth), Obstruct Police and Breach Probation

Disposition:

- Guilty plea to all three charges.
- He had 45 days pre plea custody that was enhanced to 68 days
- Count 2 & 3 = 30 days enhanced to 45 days. One day deemed served
- 12 month probation
- Count one, for CDSA charge 20 days enhanced to 30 days. To run concurrent to other sentence above.
- All other charges withdrawn



SCARLETT, Michael H (7FEB73)

Charges:

Utter forged document x 7

Disposition:

- Guilty plea to one count of utter forged document
- \$750 fine plus vic surcharge fine, 12 months probation to include 40 hours of community service, not to attend Service Canada 417 Wellington St.
