	<p><b>Charges:</b> Possess sched I substance for the purpose of trafficking Meth &amp; Fentanyl, FTC Probation, Knowledge of unauthorized possession of weapon x 2</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on October 30<sup>th</sup></li><li>• All charges were withdrawn by the Crown</li><li>• Not in the Public Interest – NPI</li><li>• Direct Accountability Program – DAP</li><li>• Has outstanding criminal matters before the court</li></ul>

	<p><b>Charges:</b> Assault, Theft under \$5000</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on October 31<sup>st</sup></li><li>• Guilty plea to assault</li><li>• Conditional discharge</li><li>• 12 months' Probation with conditions</li><li>• No contact/communication direct/indirect by any means with named parties</li><li>• Non-attendance at any known place of residence, employment or education of named parties</li><li>• Do not possess any weapons</li><li>• Theft under \$5000 was withdrawn as part of the resolution</li></ul>

**Charges:** Fraud under \$5000, Theft of a m/v

**Disposition:**

- Court appearance for sentencing on October 31<sup>st</sup>
- Guilty plea to Fraud under \$5000
- Conditional discharge
- 15 months' Probation
- Live at named address
- Do not contact/communicate in any way direct/indirect by any means named parties
- Do not attend any place where the named parties live, work, attend school
- 40 hours of community service
- \$750 charitable donation
- Theft of m/v charge withdrawn
- Has another criminal matter before the court



**Charges:** Assault BH, Assault, Mischief under \$5000, B&E

**Disposition:**

- Court appearance on October 31<sup>st</sup>
- Guilty plea to Mischief under \$5000
- Conditional discharge
- 18 months' Probation
- Live at named address
- No contact/communication direct/indirect with named parties
- Do not attend any place the named parties live, work, attend school
- Do not attend named address
- Do not possess any weapons
- Remaining charges were withdrawn as part of the resolution



**Charges:** Trafficking property obtained by crime, Theft under \$5000 from m/v x 2, Unauthorized possess of weapon, FTC undertaking x 2, Theft under \$5000 x 3, Possess sched I substance – Fentanyl , B&E

**Disposition:**

- Court appearance on October 31<sup>st</sup>
- Guilty plea to Unauthorized possess weapon, FTC undertaking x 2, Theft under \$5000 x 2, B&E
- Global sentence, 125 days in custody enhanced to 188 days, 1 day deemed served
- 12 months' Probation
- Do not attend named addresses
- Do not communicate with named parties
- DNA order
- No weapons for 10 years
- Remaining charges listed above were withdrawn as part of the resolution
- Has outstanding charges before the court
- Bail hearing was scheduled for November 3<sup>rd</sup>



**Charges:** Possession of property under \$5000 x 15, Possess prohibited weapon x 3, Unauthorized possess prohibited weapon, knowing it's unauthorized

**Disposition:**

- All charges were withdrawn



**Charge:** Over 80 BAC

**Disposition:**

- Court appearance on November 3<sup>rd</sup>
- Guilty plea to lesser charge; Careless driving
- 12 months' Probation P.O.A.
- Over 80 BAC charge withdrawn as part of the resolution
