	<p><b>Charges:</b> Theft under \$5000, FTC Probation x 2</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing on November 20<sup>th</sup></li><li>• Released on a Form 11</li><li>• Report to the John Howard Society as directed</li><li>• Do not contact/communicate in any way direct/indirect by any means with named parties</li><li>• Do not be within 100m of any place where named parties live, work, go to school, frequent</li><li>• Do not be within 100m of named parties</li><li>• Do not attend named address</li><li>• Do not possess any weapons</li><li>• Next court date is November 28<sup>th</sup></li></ul>

	<p><b>Charges: Bayham OPP -</b> Operate conveyance dangerous, Assault with a weapon, Fail to stop conveyance involved in crash, Operate while prohibited, FTC release, Possess property obtained by crime not exceeding \$5000 x 5</p> <p><b>Central Elgin OPP –</b> Theft under \$5000</p> <p><b>STPS –</b> FTC release order</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing on November 23<sup>rd</sup></li><li>• Released on a Form 11</li><li>• Promise to pay \$750 if FTC with the release order</li><li>• Report to the John Howard Society as directed</li><li>• Do not contact/communicate in any way direct/indirect by any means with the all named parties</li><li>• Do not attend named addresses</li><li>• Do not operate or have care/control of a m/v</li><li>• Next court date is December 5<sup>th</sup></li></ul>

	<p><b>Charge:</b> Utter death threats</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on November 21<sup>st</sup></li><li>• Charge withdrawn by the Crown</li><li>• Counselling completed</li></ul>

	<p><b>Charge:</b> Assault</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on November 21<sup>st</sup></li><li>• Guilty plea to assault</li><li>• 12 months' Probation</li><li>• \$500 fine</li><li>• Do not contact/communicate direct/indirect by any means with named parties</li><li>• Do not attend anywhere the named parties live, work, attend school</li><li>• Do not attend within 100m of named address</li><li>• Do not possess any weapons</li><li>• Perform 8 hours of community service</li></ul>
	<p><b>Charges:</b> Unauthorized possession of a firearm x 5</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on November 21<sup>st</sup></li><li>• Charge withdrawn</li><li>• No public interest – NPI</li><li>• No reasonable prospect of conviction - NRPC</li></ul>
	<p><b>Charge:</b> FTC</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on November 21<sup>st</sup></li><li>• DAP completed</li><li>• Charge withdrawn</li><li>• Has another criminal matter before the court</li></ul>

	<p><b>Charges:</b> Assault x 5, Aggravated assault, Forcible confinement</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on November 21<sup>st</sup></li><li>• Entered into a 12 months' Common Law Peace Bond –CLPB</li><li>• No contact with named party</li><li>• Non-attendance at any known place of residence, employment or education of named party</li><li>• Complete the Changing Ways Program within 8 months</li><li>• All charges were withdrawn</li></ul>
	<p><b>Charge:</b> Assault</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on November 21<sup>st</sup></li><li>• 12 months' CLPB</li><li>• No contact/communication with named party</li><li>• Do not possess any weapons</li><li>• Charge withdrawn</li></ul>
	<p><b>Charge:</b> Theft under \$5000</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on November 22<sup>nd</sup></li><li>• Extra Judicial Sanctions – EJS completed</li><li>• Charge withdrawn</li></ul>
	<p><b>Charges:</b> Impaired operation, Fail to remain - HTA</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on November 22<sup>nd</sup></li><li>• Guilty plea to lesser offence; Fail to report – HTA</li><li>• Impaired charge withdrawn NRPC, zero alcohol in breath test and clean toxicology report</li></ul>

	<p><b>Charge:</b> Drive under suspension - HTA</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• POA court appearance on November 22<sup>nd</sup></li> <li>• Found guilty of Drive under suspension</li> <li>• Sentenced to 21 days custody – intermittent</li> <li>• Probation order in effect while serving sentence</li> </ul>
	<p><b>Charge:</b> Impaired operation - drug</p> <p><b>Released:</b></p> <ul style="list-style-type: none"> <li>• Court appearance on November 24<sup>th</sup></li> <li>• Guilty plea to lesser offence; Careless driving</li> <li>• \$1,000 fine</li> <li>• 12 months' POA Probation order</li> <li>• Do not operate a motor vehicle except with a blood alcohol concentration above zero</li> <li>• Complete the Back on Track remedial program</li> </ul>
	<p><b>Charges:</b> B&amp;E dwelling, FTC release x 2</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Court appearance on November 24<sup>th</sup></li> <li>• Guilty plea to; B&amp;E with intent, FTC x 2</li> <li>• Sentenced to 6 months less PSC (credit for 5 months PSC)</li> <li>• 18 months' Probation</li> <li>• No contact with named party</li> <li>• Do not attend named address</li> <li>• Do not possess B&amp;E instruments</li> <li>• DNA sample</li> <li>• Remanded into custody</li> </ul>
