<ul> <li>Charges: Assault – Spousal x 4, Forcible confinement, Harassing communication</li> <li>Released: <ul> <li>Bail hearing on December 5<sup>th</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$2000 if FTC with release order</li> <li>Notify STPS OIC of change of address within 24 hours</li> <li>Do not contact/communicate in any way direct/indirect by any means with named party</li> <li>Do not be within 25m of any place where named party lives, works, goes to school, frequents, or knows named party to be except for court appearances</li> <li>Do not attend named address</li> <li>Do not possess any weapons</li> <li>Next court date is January 9<sup>th</sup></li> </ul> </li> </ul>

<ul> <li>Charges: FTC Probation x 2, Assault BH</li> <li>Disposition: <ul> <li>Bail hearing on December 5<sup>th</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$500 if FTC with the release order</li> <li>Report to the John Howard Society as directed</li> <li>Do not be within 25m of named party</li> <li>Do not be within 25m of named address</li> <li>Do not possess any weapons</li> <li>Next court date is December 12<sup>th</sup></li> </ul> </li> </ul>
<ul> <li>Charges: Fraud not exceeding \$5000 x 2, Possess property obtained by crime not exceeding \$5000</li> <li>Released: <ul> <li>Bail hearing on December 6<sup>th</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$500 if FTC with release order</li> <li>Report to the John Howard Society as directed</li> <li>Do not contact/communicate in any way direct/indirect by any means with named parties</li> <li>Do not possess any ID, bank card, cheque, bank document unless she can prove it has been lawfully issued</li> <li>Next court date is December 19<sup>th</sup></li> </ul> </li> </ul>

<ul> <li>Charges: Assault with a weapon, Utter threats – BH, Causing a Disturbance, Mischief x 2, Theft under \$5000</li> <li>Disposition: <ul> <li>Court appearance on December 5<sup>th</sup></li> <li>Guilty pleas to lesser offence of Assault, and utter threats</li> <li>30 days less PSC</li> <li>12 months' Probation</li> <li>Do not attend named location</li> <li>Do not contact/communicate with named parties</li> <li>S. 110 Order for 5 years</li> <li>DNA</li> </ul> </li> </ul>
