- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Report to the John Howard Society as directed
- Do not be within 25m of named party
- Do not be within 25m of named address
- Do not possess any weapons
- Next court date is December 12th



Charges: Fraud not exceeding \$5000 x 2, Possess property obtained by crime not exceeding \$5000

Released:

- Bail hearing on December 6th
- Released on a Form 11
- Promise to pay \$500 if FTC with release order
- Report to the John Howard Society as directed
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not possess any ID, bank card, cheque, bank document unless she can prove it has been lawfully issued
