## Dispositions:

	<p><b>Charges:</b> Possession property obtained by crime under \$5000</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on November 27<sup>th</sup></li><li>• Charge withdrawn by the Crown</li><li>• No public interest – NPI</li><li>• Has outstanding criminal matters before the court</li></ul>
	<p><b>Charge:</b> Theft under \$5000</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on November 28<sup>th</sup></li><li>• Direct Accountability Program – DAP completed</li><li>• Charge withdrawn</li></ul>



**Charges:** FTC release order x 2, Assault with a weapon, Unlawfully in a dwelling, Criminal harassment, Possession of a prohibited weapon while prohibited, Assault, Unauthorized possession of a prohibited weapon

**Disposition:**

- Court appearance on November 28<sup>th</sup>
- All charges were withdrawn by the Crown
- No reasonable prospect of conviction – NRPC
- The victim was uncooperative as per the Crown
- Has other criminal matters before the court



**Charges:** Assault with a weapon, Possess property obtained by crime over \$5000, Obstruct police, Possess property obtained by crime under \$5000, Possess break in instruments, Drive while under suspension, Use plate not authorized for m/v – HTA

**Disposition:**

- Court appearance on November 28<sup>th</sup>
- Guilty plea to; Assault with a weapon, Possess property over \$5000, Obstruct police
- 1 day deemed served; 40 days of PSC enhanced to 60 days
- 24 months' Probation
- No contact/communicate in any way direct/indirect by any means with named parties
- Do not attend any known place of residence, employment, or education of named parties
- Do not possess any weapons
- DNA order
- S. 110 order -10 years



**Charges:** Assault, Utter threats – BH, Mischief

**Disposition:**

- Court appearance on November 28<sup>th</sup>
- DAP completed
- All charges withdrawn



**Charges:** Impaired driving – drug, Fail to stop after accident  
Novice driver – presence of drug, Drive m/v no currently  
Validated permit, G1 license – unaccompanied by qualified  
Driver, Fail to have insurance card

**Disposition:**

- Court appearance on November 28<sup>th</sup>
- Guilty plea to Impaired by drug
- \$2000 fine
- 12 months' driving prohibition
- Remaining charges were withdrawn as part of the resolution



**Charges:** Theft under \$5000, FTC undertaking, FTC Probation

**Disposition:**




- Court appearance on November 28<sup>th</sup>
- Guilty plea to Theft under \$5000 x 2, FTC undertaking,  
Breach Probation
- Sentenced to 135 days custody
- 56 days of PSC enhanced to 84 days - 51 days to serve
- 12 months' Probation
- Do not attend within 100m of named addresses.
- Do not communicate with named parties






**Charges:** Assault x 3, Theft under \$5000 x 2, FTC Probation x 3,  
Utter death threats

**Disposition:**

- Court appearance on November 28<sup>th</sup>
- Guilty plea to Theft under \$5000, Assault x 2
- 1 day deemed served, 61 days PSC enhanced to 91 days
- 12 months' Probation
- Do not contact/communicate in any way direct/indirect by any  
means with named parties
- Do not attend at named addresses
- Do not possess any weapons
- Remaining charges were withdrawn as part of the resolution

	<p><b>Charges:</b> Possession of schedule I substance for the purpose of trafficking x 3, Possession of a scheduled IV substance for the purpose of trafficking x , Possession of schedule II substance, Unauthorized possession of a weapon x 2, FTC Probation x 5, FTC release order x 2, Trafficking stolen goods under \$5000, Possess property obtained by crime under \$5000, Possess prohibited weapon x 2</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on November 28<sup>th</sup></li><li>• Guilty plea to Possession schedule II substance and Unauthorized possession of a prohibited weapon</li><li>• Suspended sentence</li><li>• 12 months' Probation</li><li>• Weapons prohibition</li><li>• All remaining charges were withdrawn by the Crown</li></ul>
	<p><b>Charges:</b> Theft under \$5000, Disguise with intent, FTC, Possession of schedule I substance – crystal meth</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on November 28<sup>th</sup></li><li>• Guilty plea to disguise with intent</li><li>• Sentenced to 41 days, time served</li><li>• 2 years' Probation</li><li>• Curfew 11pm – 6am</li><li>• No contact/communication direct/indirect by any means with named party</li><li>• Do not attend named address</li><li>• Perform 100 hours of community service within 12 months</li></ul>
	<p><b>Charges:</b> Assault x 3</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on November 28<sup>th</sup></li><li>• Entered into a 12 months' CLPB</li><li>• No contact/communication with named party</li><li>• Do not attend at any known place of residence, employment or education of named party</li><li>• No weapons</li><li>• Has outstanding charges before the court</li></ul>

	<p><b>Charges:</b> Prohibited operation, Obstruct police, Possess sched I Substance – fentanyl, Possess sched I substance – cocaine, FTC Probation x 2, Possess prohibited device, FTC release, Drive under suspension – HTA x 5, Fail to surrender D/L</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Court appearance on November 29<sup>th</sup></li> <li>• Guilty plea to; FTC Probation, Possess sched I substance x 2 – fentanyl and cocaine, Unauthorized possession of prohibited weapon, Obstruct police, Prohibited operation – CCC</li> <li>• Sentenced to 135 days, time served</li> <li>• 12 Months' Probation</li> <li>• Do not possess any weapons</li> <li>• Do not occupy the driver's seat of a motor vehicle</li> <li>• Remaining charges were withdrawn as part of the resolution</li> </ul>
	<p><b>Charge:</b> Theft under \$5000</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Court appearance on November 30<sup>th</sup></li> <li>• DAP completed</li> <li>• Charge withdrawn</li> </ul>
	<p><b>Charge:</b> Sexual assault</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Court appearance for scheduled trial</li> <li>• Guilty plea to lesser offence, assault</li> <li>• Sentenced to 109 days; 1 day deemed served</li> <li>• 12 months' Probation</li> <li>• Do not contact/communicate in any way direct/indirect by any means with named party</li> <li>• Do not attend within 25m any know residence, employment, or education of named party</li> <li>• Do not be within 5m of named party</li> <li>• Do not possess any weapons</li> </ul>



**Charge:** Utter death threat

**Disposition:**

- Court appearance on November 30<sup>th</sup>
- Entered into a 12 months' Peace Bond
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not be within 50m of any place the named parties live, work, go to school, or any place they are known to be
- Has outstanding charges before the court
