Released:

	<p>Charges: FTC x 3 YCJA</p> <p>Released:</p> <ul style="list-style-type: none">• Bail hearing on December 9th• Released on a Form 11• Remain in residence daily between the hours of 9pm – 7am except medical emergencies involving themselves or immediate family and except for in the presence of named parties• Remanded into custody• Next court date is December 18th
	<p>Charges: Mischief under \$5000 x 2, Theft under \$5000</p> <p>Released:</p> <ul style="list-style-type: none">• Bail hearing on December 11th• Reside at named address, do not change address without the consent of worker• Do not possess any weapons• Arrested on December 12th• Bail hearing on December 13th• Re-released on a Form 11 with the same conditions• Next court date is January 17th



Charges: -STPS-

Resist arrest, FTA court, Possession under \$5000, Fraud
Fraud with intent, Forgery

-APS-

Theft under \$5000 x 2

Released:

- Bail hearing on December 12th
- Released on a Form 11
- Promise to pay \$200 if FTC with release order
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend named addresses
- Next court date is December 19th



Charges: Theft under \$5000, Breach Probation

Released:

- Bail hearing on December 12th
- Released on a Form 11
- Promise to pay \$250 if FTC with release order
- Do not attend named address
- Next court date is January 30th



Charge: FTC with release order

Released:

- Bail hearing on December 13th
- Released on a Form 11
- Report to STPS for the purposes of fingerprints no later than 4pm on December 15th
- Next court date is January 2nd



Charges: Robbery with violence

Released:

- Bail hearing on December 15th
- Released on a Form 11
- Promise to pay \$500 if FTC with release order
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend any place where named party lives, works or goes to school
- Do not attend within 100m of named address
- Do not possess any weapons
- Next court date is January 9th

Charge: Break & Enter

Disposition:

- Court appearance on December 11th
- Charge withdrawn
- Diversion completed
- Entered into a 12 months' Common Law Peace Bond
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend named address
- Has outstanding charges before the court



Charges: Forcible confinement, Assault x 2

Released:




- Court appearance on December 12th
- Guilty plea to assault
- 12 months' Probation with terms
- Reside at named address
- No contact/communication in any way direct/indirect by any means with named party
- Do not attend within 100m of any known place of residence, employment or education of named party
- Do not be within 25m of the named party
- Successfully complete Changing Ways within the first eight months of the probation order
- No weapons
- Remaining charges were withdrawn as part of the resolution



Charges: Trespass at night, Theft under \$5000, Possess Property obtained by crime under \$5000, FTC Probation, FTC undertaking

Released:

- Court appearance on December 12th
- Guilty plea to Possess property obtained by crime under \$5000, FTC undertaking
- 45 days conditional sentence, house arrest
- 12 months' Probation
- Live at named address, confined to the address for duration of the sentence order with exceptions on Wednesday between 12pm – 4pm and emergencies
- Do not purchase, possess, or consume alcohol or drugs
- Present at the doorway upon the request of police
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend named address or any known place the named party lives, works or attends school

	<p>Charges: Sexual assault, Assault – choking, Assault</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on December 12th• Entered into a 4 years’ CLPB• No contact/communication in any way direct/indirect by any means with named party• Not to be within 250m of any known place of residence, employment or education of named party• Not to be within 25m of named party• Participate in the Changing Ways Program and complete it within eight months of this order• No weapons• Charges were withdrawn as part of the resolution
	<p>Charge: Assault - BH</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on December 12th• Charge withdrawn by the Crown• No reasonable prospect of conviction - NRPC
	<p>Charges: Utter death threat</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on December 12th• Guilty plea to utter death threats• Conditional Discharge• 12 months’ Probation• No contact/communication either directly/indirectly with named party• Non-attendance at any place or residence, employment or education of named party• Do not be within 10m of named party• Do not possess any weapons



Charges: Theft under \$5000 x 2, FTC Probation x 2, FTC release order x 12, Dangerous operation, Obstruct police, FTC undertaking, Drive under suspension x 3 –HTA

Disposition:

- Court appearance on December 12th in London
- Guilty pleas to; FTC release x 5, Dangerous operation, FTC undertaking
- 1-day deemed time-served (60 days of PPC enhanced to 90 days)
- 2 years' Probation order
- Do not attend named address
- No weapons
- Not to attend at any premises primarily licenced to sell liquor
- Remaining charges were withdrawn as part of the resolution



Charges: Assault – Police x 3, Assault BH – Police, Resist Arrest x 2, Utter threats – Death, FTC

Disposition:




- Court appearance on December 13th
- Guilty pleas to; Assault BH, Assault Police, FTC
- Time served, 24 days enhanced to 32
- 2 years' Probation
- Reside at named address
- No weapons
- Do not purchase, consume, possess alcohol or other intoxicating substances

	<p>Charges: Assault x 2, Utter death threats, FTC undertaking</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on December 15th• Guilty plea to Assault, Utter death threat• Conditional discharge• 12 months' Probation• Do not contact/communicate in any way direct/indirect by any means with named party• Do not attend at any known place where named party lives, works, goes to school or frequents• Do not possess any weapons• Complete the Changing Ways program
	<p>Charge: Assault - Spousal</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on December 15th• Entered into a 12 months' CLPB• Keep the peace and be of good behavior towards named party• Charge withdrawn
