- Do not attend named address
- Do not attend within 2m of named party
- No weapons
- Next court date is February 6th

	<p>Charges: Impaired operation, Possess schedule I substance, crystal meth and fentanyl</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on January 11th• Guilty plea to Impaired driving• 12 months' Probation• \$1000 fine• 12 months' driving prohibition• CDSA charges were withdrawn as part of the resolution
	<p>Charges: Sexual assault, Assault x 2 - Spousal</p> <p>Disposition:</p> <ul style="list-style-type: none">• Jury trial January 8 – 11th• The victim was unable to continue testimony• Mistrial was declared• Plead guilty to an assault charge• Conditional discharge plus 12 months' Probation• Do not contact/communicate in any way direct/indirect by any means with named party• Do not be within 100m of any place the named party lives, works or attends school• Do not possess any weapons• Remaining charges were withdrawn as part of the resolution



Charge: Breach Probation

Disposition:

- Court appearance on January 12th
- Charge withdrawn by the Crown
- Covid based – Not in the public interest (NPI)



Charges: APS – Assault, S. 810 Peace Bond
STPS - Theft under \$5000

Disposition:

- Court appearance on January 12th
- Entered into a 12 months' Peace Bond
- Do not have any contact with named party
- Do not attend within 100m of any known place of residence employment, or education of named party
- All charges were withdrawn
- Is wanted by STPS on an endorsed warrant for harassing communications
