<ul> <li>Charges: FTC undertaking, Assault, Mischief</li> <li>Released: <ul> <li>Bail hearing on December 26<sup>th</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$250 if FTC with release order</li> <li>Do not contact/communicate in any way direct/indirect by any means with named party</li> <li>Do not attend within 25m of named address</li> <li>Do not possess any weapons</li> <li>Next court date is January 16<sup>th</sup></li> </ul> </li> </ul>
<ul> <li>Charges: Steal credit card, Use credit card x 4, Fraud under \$5000 x 2, Possess property under \$5000</li> <li>Released: <ul> <li>Bail hearing on January 2<sup>nd</sup>, 2024</li> <li>Released on a Form 11</li> <li>Next court date is January 16<sup>th</sup></li> </ul> </li> </ul>

<ul> <li>Charge: Mischief</li> <li>Released: <ul> <li>Bail hearing on January 4<sup>th</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$100 if FTC with the release order</li> <li>Contact the Direct Accountability Program by January 5<sup>th</sup></li> <li>Next court date is January 30<sup>th</sup></li> </ul> </li> </ul>
<ul> <li>Charges: Mischief under \$5000 x 5, False alarm of fire, FTC</li> <li>Released: <ul> <li>Bail hearing on January 4<sup>th</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$1000 if FTC with the release order</li> <li>Do not contact/communicate in any way direct/indirect by any means with named parties</li> <li>Do not attend named location</li> <li>Do not possess any weapons</li> <li>Next court date is January 16<sup>th</sup></li> </ul> </li> </ul>
<ul> <li>Charges: Assault x 2, Utter threat x 2</li> <li>Released: <ul> <li>Bail hearing on January 4<sup>th</sup></li> <li>Released on a Form 11</li> <li>Do not contact/communicate in any way direct/indirect by any means with named party</li> <li>Do not attend any place of employment, education, residence or any other place named party is known to be</li> <li>Do not possess any weapons</li> <li>Next court date is January 10<sup>th</sup></li> </ul> </li> </ul>

## **Dispositions:**

<ul> <li>Charges: Impaired riving – Over 80 BAC Fail to notify change in address, No proper red light - HTA</li> <li>Disposition: <ul> <li>Court appearance on December 29<sup>th</sup></li> <li>Guilty plea to lesser offence; Careless driving</li> <li>\$1500 fine</li> <li>12 months' POA Probation order</li> <li>Do not operate a conveyance except with a blood alcohol concentration of zero</li> <li>Complete the Back on Track remedial program and provide proof of completion within the first 9 months of his probation</li> <li>Remaining charges were withdrawn as part of the resolution</li> </ul> </li> </ul>
<ul> <li>Charges: Theft under \$5000, Breach Probation</li> <li>Disposition: <ul> <li>Court appearance on January 2<sup>nd</sup></li> <li>DAP completed</li> <li>Charge withdrawn by the Crown</li> </ul> </li> </ul>
<ul> <li>Charges: Prohibited operation, Possess prohibited weapon, Possess Property obtained by crime over \$5000, FTC x 4</li> <li>Disposition: <ul> <li>Court appearance on January 2<sup>nd</sup></li> <li>Guilty pleas to the following, Prohibited operation, FTC x 2, Possess property over \$5000</li> <li>Sentenced to 120 days jail less PSC (86 days of PSC), 1 day deemed served</li> <li>18 months' Probation with terms to report, reside as directed, and take counselling as directed</li> <li>Remaining charges were withdrawn as part of the resolution</li> </ul> </li> </ul>

<ul> <li>Charges: STPS – Theft under \$5000 OPP - Utter death threat - Police</li> <li>Disposition: <ul> <li>Court appearance on January 2<sup>nd</sup></li> <li>Guilty plea to Utter death threat – police</li> <li>32 days of enhanced custody (21 actual days), time served</li> <li>12 months' Probation usual conditions</li> <li>No weapons</li> <li>20 hours of community service</li> <li>DNA</li> <li>s. 110 – 10 years weapons prohibition</li> </ul> </li> </ul>
<ul> <li>Charge: B&amp;E</li> <li>Disposition: <ul> <li>Court appearance on January 3<sup>rd</sup></li> <li>Guilty plea to lesser offence, Mischief under \$5000</li> <li>Conditional discharge</li> <li>12 months' Probation</li> <li>25 hours community service</li> <li>Do not attend within 25m of named address</li> </ul> </li> </ul>
<ul> <li>Charges: FTC Probation x 2, Possess property over \$5000 x 2, FTC release order, Possess schedule 1 x 2, Meth &amp; Fentanyl, Trespass/prowl at night</li> <li>Disposition: <ul> <li>Court appearance on January 3<sup>rd</sup></li> <li>Guilty pleas to; FTC Probation x 1, Possess property over \$5000 x 1, Trespass at night</li> <li>26 days PPC, 1 day deemed served</li> <li>Remaining charges were withdrawn as part of the resolution</li> </ul> </li> </ul>
