- 18 months' Probation
- No contact with named parties; not to be within 25m of named party; remain away from where they live, work or go to school
- CLPB – 12 months; Do not contact/communicate direct/indirect by any means
- No weapons
- Remaining charges were withdrawn as part of the resolution



Charges: Theft under \$5000, Assault with a weapon, Assault BH, Fraud under \$5000, Possess property obtained by crime under \$5000

Disposition:

- Court appearance on January 23rd
- Guilty plea lesser offence of Assault, Assault with a weapon, Possess property obtained by crime under \$5000
- 120 days jail sentence less PSC (71 enhanced to 107); 13 days left to serve
- 12 months' Probation
- No contact/communication with all named parties
- Do not attend any place where the named parties live, work, attend school
- Do not possess any ID, card with a data strip/security chip, bank issued document unless it has been lawfully issued in name
