<ul> <li>Charges: Assault with a weapon, FTC release order x 4, Possess a dangerous weapon, Possession under \$5000, Assault x 2, Prowl at night, Assault police x 2, Cause fear or injury, Theft under \$5000 x 2</li> <li>Released: <ul> <li>Bail hearing on January 14<sup>th</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$200 if FTC with the release order</li> <li>Do not contact/communicate in any way direct/indirect by any means with named parties</li> <li>Do not attend named address</li> <li>Do not possess any weapons</li> <li>Next court date is February 6<sup>th</sup></li> </ul> </li> </ul>
<ul> <li>Charges: B&amp;E, Possess instruments with intent to B&amp;E, Breach Probation x 2, FTC, Mischief, Counterfeit money x 2, Fraud under \$5000, Fraud</li> <li>Released: <ul> <li>Bail hearing on January 15<sup>th</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$500 if FTC with the release order</li> <li>Report to the John Howard Society as directed</li> <li>Do not contact/communicate in any way direct/indirect by any means with named party</li> <li>Do not attend named address</li> <li>Do not possess B&amp;E tools</li> <li>Next court date is February 13<sup>th</sup></li> </ul> </li> </ul>

<ul> <li>Charges: Theft under \$5000 x 3</li> <li>Released: <ul> <li>Bail hearing on January 15<sup>th</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$500 if FTC with the release order</li> <li>Reside at named residence</li> <li>Do not attend named locations</li> <li>Next court date is February 6<sup>th</sup></li> </ul> </li> </ul>
<ul> <li>Charges: FTC Probation, Mischief</li> <li>Released: <ul> <li>Bail hearing on January 18<sup>th</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$250 if FTC with the release order</li> <li>Report to Probation as directed</li> <li>Do not be within 25m of named address</li> <li>Next court date is January 23<sup>rd</sup></li> </ul> </li> </ul>

Charges: Robbery with weapon, FTC x 2
<ul> <li>Disposition:</li> <li>Sentencing on January 15<sup>th</sup></li> <li>Guilty plea to Robbery with weapon</li> <li>Sentenced to 15 months' conditional sentence order, see order for specific conditions</li> <li>GPS monitoring device to be installed and must follow the guidelines outlined in the order</li> <li>House arrest, only permitted on Tuesdays b/w 9am- 1pm to conduct the necessities of life,</li> <li>Do not purchase, possess, consume alcohol or drugs unless prescribed</li> <li>Remain in the province of Ontario</li> <li>Reside at named address</li> <li>240 hours community service</li> <li>Do not contact/communicate direct/indirect by any means with named party</li> <li>Do not possess any weapons</li> <li>Remaining charges were withdrawn</li> </ul>
<ul> <li>Charges: OPP – Assault STPS – Utter death threats, Utter threats BH, FTC x 2, FTC YCJA x 2, Mischief x 2</li> <li>Disposition: <ul> <li>Court appearance on January 16<sup>th</sup></li> <li>Guilty pleas to Utter death threat, FTC</li> <li>Conditional Discharge, plus 18 months' Probation</li> <li>No contact with named parties</li> <li>Non-attendance at any known place of residence, employment or education of named parties</li> <li>40 hours community service</li> <li>No weapons</li> <li>DNA</li> <li>Remaining charges were withdrawn as part of the resolution</li> </ul> </li> </ul>

<ul> <li>Charge: Theft by person holding power of attorney</li> <li>Disposition: <ul> <li>Court appearance on January 16<sup>th</sup></li> <li>Charge withdrawn</li> <li>No reasonable prospect of conviction - NRPC</li> <li>The victim is no longer wishing to cooperate with the charge proceeding</li> </ul> </li> </ul>
<ul> <li>Charges: Criminal harassment, Mischief</li> <li>Disposition: <ul> <li>Court appearance on January 16<sup>th</sup></li> <li>Guilty plea to Mischief</li> <li>Conditional discharge plus 24 months' Probation</li> <li>No contact or communication with named party</li> <li>Complete Changing Ways</li> <li>Do not possess any weapons</li> <li>Remaining charge was withdrawn as part of the resolution</li> </ul> </li> </ul>
Charge: B&E Disposition: • Court appearance on January 16 <sup>th</sup> • Charge withdrawn • NRPC • Has outstanding charges before the court

<ul> <li>Charges: Theft under \$5000, FTC release order x 2, FTC Probation x 5</li> <li>Disposition: <ul> <li>Court appearance on January 16<sup>th</sup></li> <li>Guilty pleas to FTC Probation x 2, FTC release order</li> <li>Six months jail reduced to 165 days for conditions at EMDC - taking into account PSC of 54 days enhanced to 81 days credit, 84 days to be served</li> <li>Remaining charges were withdrawn as part of the resolution</li> </ul> </li> </ul>
<ul> <li>Charges: Assault x 2, Utter threat, Forcible confinement, FTC x 2</li> <li>Disposition: <ul> <li>Court appearance on January 16<sup>th</sup></li> <li>Guilty plea to FTC release order</li> <li>Suspended sentence plus 12 months' Probation</li> <li>No contact with named parties</li> <li>Do not attend at any place of residence, employment or education of named parties</li> <li>Remaining charges were withdrawn as part of the resolution</li> </ul> </li> </ul>
Charge: FTC Probation Disposition: • Court appearance on January 16 <sup>th</sup> • Guilty plea to FTC • \$300 fine • 9 months' Probation • 68 hours of community service

<ul> <li>Charge: Assault</li> <li>Disposition: <ul> <li>Court appearance on January 16<sup>th</sup></li> <li>Entered into a 12 months' CLPB</li> <li>Assault charge was withdrawn</li> <li>No contact with named party</li> <li>Do not attend within 5m of the named party</li> </ul> </li> </ul>
Charges: Assault, Mischief         Disposition:         • Court appearance on January 17 <sup>th</sup> • Guilty plea to assault         • 12 Months' Probation         • No contact or communication with named parties         • Do not attend within 50m of any place the named parties live, work or attend school         • 20 community service hours         • No weapons
<ul> <li>Charges: APS – Mischief under \$5000 Probation - FTC YCJA x 2</li> <li>Disposition: <ul> <li>Court appearance on January 17<sup>th</sup></li> <li>Probation charge was stayed by the Crown</li> <li>Remaining charges were withdrawn by the Crown - NPI</li> </ul> </li> </ul>

<ul> <li>Charges: FTC YCJA x 5, FTC release order</li> <li>Disposition: <ul> <li>Court appearance on January 17<sup>th</sup></li> <li>Guilty pleas to FTC YCJA and FTC release order</li> <li>Time served, plus serve 5 hours of community service</li> <li>Suspended sentence plus Probation</li> <li>Remaining charges were withdrawn</li> <li>Has new charges, was released on appearance notice</li> </ul> </li> </ul>
<ul> <li>Charges: Utter death threat, FTC x 2, Mischief, Assault x 2, Unlawfully in a dwelling</li> <li>Disposition: <ul> <li>Court appearance on January 17<sup>th</sup></li> <li>Guilty pleas to assault and FTC</li> <li>17 days custody; time served</li> <li>12 Months' Probation</li> <li>20 hours community service, counselling</li> <li>No contact/communication in any way direct/indirect by any means with named parties</li> <li>Do not be within 50m of where the named parties live, work, attend school</li> <li>Do not be within 25m of the named parties</li> <li>Do not possess any weapons</li> </ul> </li> </ul>
<ul> <li>Charge: Breach of conditional sentence order</li> <li>Disposition: <ul> <li>Court appearance on January 17<sup>th</sup></li> <li>Charge withdrawn</li> <li>Crown failed to have them appear before a Justice for the purpose of commencing the hearing within 30 days</li> <li>Jurisdiction lost, Remains in custody on outstanding substantive charges</li> </ul> </li> </ul>
