	<p><b>Charges:</b> Assault with a weapon, FTC release order x 4, Possess a dangerous weapon, Possession under \$5000, Assault x 2, Prowl at night, Assault police x 2, Cause fear or injury, Theft under \$5000 x 2</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing on January 14<sup>th</sup></li><li>• Released on a Form 11</li><li>• Promise to pay \$200 if FTC with the release order</li><li>• Do not contact/communicate in any way direct/indirect by any means with named parties</li><li>• Do not attend named address</li><li>• Do not possess any weapons</li><li>• Next court date is February 6<sup>th</sup></li></ul>

	<p><b>Charges:</b> Possession for the purpose of trafficking – Cocaine, Possession of schedule I substance x 3; Dilaudid 8mg, Ecstasy, Psilocybin</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Court appearance on January 15<sup>th</sup></li> <li>• All charges were withdrawn by the Federal Crown</li> <li>• No public interest</li> </ul>

	<p><b>Charges:</b> Robbery with weapon, FTC x 2</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Sentencing on January 15<sup>th</sup></li><li>• Guilty plea to Robbery with weapon</li><li>• Sentenced to 15 months' conditional sentence order, see order for specific conditions</li><li>• GPS monitoring device to be installed and must follow the guidelines outlined in the order</li><li>• House arrest, only permitted on Tuesdays b/w 9am- 1pm to conduct the necessities of life,</li><li>• Do not purchase, possess, consume alcohol or drugs unless prescribed</li><li>• Remain in the province of Ontario</li><li>• Reside at named address</li><li>• 240 hours community service</li><li>• Do not contact/communicate direct/indirect by any means with named party</li><li>• Do not attend named address</li><li>• Do not possess any weapons</li><li>• Remaining charges were withdrawn</li></ul>
	<p><b>Charges:</b> <b>OPP</b> – Assault <b>STPS</b> – Utter death threats, Utter threats BH, FTC x 2, FTC YCJA x 2, Mischief x 2</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on January 16<sup>th</sup></li><li>• Guilty pleas to Utter death threat, FTC</li><li>• Conditional Discharge, plus 18 months' Probation</li><li>• No contact with named parties</li><li>• Non-attendance at any known place of residence, employment or education of named parties</li><li>• 40 hours community service</li><li>• No weapons</li><li>• DNA</li><li>• Remaining charges were withdrawn as part of the resolution</li></ul>



**Charge:** Theft by person holding power of attorney

**Disposition:**

- Court appearance on January 16<sup>th</sup>
- Charge withdrawn
- No reasonable prospect of conviction - NRPC
- The victim is no longer wishing to cooperate with the charge proceeding



**Charges:** Criminal harassment, Mischief

**Disposition:**




- Court appearance on January 16<sup>th</sup>
- Guilty plea to Mischief
- Conditional discharge plus 24 months' Probation
- No contact or communication with named party
- Complete Changing Ways
- Do not possess any weapons
- Remaining charge was withdrawn as part of the resolution



**Charge:** B&E

**Disposition:**

- Court appearance on January 16<sup>th</sup>
- Charge withdrawn
- NRPC
- Has outstanding charges before the court

	<p><b>Charges:</b> Theft under \$5000, FTC release order x 2, FTC Probation x 5</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on January 16<sup>th</sup></li><li>• Guilty pleas to FTC Probation x 2, FTC release order</li><li>• Six months jail reduced to 165 days for conditions at EMDC - taking into account PSC of 54 days enhanced to 81 days credit, 84 days to be served</li><li>• Remaining charges were withdrawn as part of the resolution</li></ul>
	<p><b>Charges:</b> Assault x 2, Utter threat, Forcible confinement, FTC x 2</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on January 16<sup>th</sup></li><li>• Guilty plea to FTC release order</li><li>• Suspended sentence plus 12 months' Probation</li><li>• No contact with named parties</li><li>• Do not attend at any place of residence, employment or education of named parties</li><li>• Remaining charges were withdrawn as part of the resolution</li></ul>

**Charge:** Assault

**Disposition:**

- Court appearance on January 16<sup>th</sup>
- Entered into a 12 months' CLPB
- Assault charge was withdrawn
- No contact with named party
- Do not attend within 5m of the named party



**Charges:** Assault, Mischief

**Disposition:**

- Court appearance on January 17<sup>th</sup>
- Guilty plea to assault
- 12 Months' Probation
- No contact or communication with named parties
- Do not attend within 50m of any place the named parties live, work or attend school
- 20 community service hours
- No weapons



**Charges:** APS – Mischief under \$5000  
**Probation** - FTC YCJA x 2

**Disposition:**

- Court appearance on January 17<sup>th</sup>
- Probation charge was stayed by the Crown
- Remaining charges were withdrawn by the Crown - NPI



**Charges:** FTC YCJA x 5, FTC release order

**Disposition:**

- Court appearance on January 17<sup>th</sup>
- Guilty pleas to FTC YCJA and FTC release order
- Time served, plus serve 5 hours of community service
- Suspended sentence plus Probation
- Remaining charges were withdrawn
- Has new charges, was released on appearance notice



**Charges:** Utter death threat, FTC x 2, Mischief, Assault x 2, Unlawfully in a dwelling

**Disposition:**

- Court appearance on January 17<sup>th</sup>
- Guilty pleas to assault and FTC
- 17 days custody; time served
- 12 Months' Probation
- 20 hours community service, counselling
- No contact/communication in any way direct/indirect by any means with named parties
- Do not be within 50m of where the named parties live, work, attend school
- Do not be within 25m of the named parties
- Do not possess any weapons



**Charge:** Breach of conditional sentence order

**Disposition:**

- Court appearance on January 17<sup>th</sup>
- Charge withdrawn
- Crown failed to have them appear before a Justice for the purpose of commencing the hearing within 30 days
- Jurisdiction lost, Remains in custody on outstanding substantive charges



**Charge:** Impaired operation

**Disposition:**

- Court appearance on January 19<sup>th</sup>
- Guilty plea to lesser charge, Careless driving
- \$1000 fine
- 12 months' P.O.A. Probation order
- Impaired charge was withdrawn



**Charges:** Assault, Breach Peace Bond

**Disposition:**

- Court appearance on January 19<sup>th</sup>
- 12 months' Common Law Peace Bond
- Same conditions as previous undertaking
- No contact/communication with named party
- Do not attend named address
- Charges withdrawn as part of the resolution
