	<p>Charges: FTC Probation x 2, Possess sched I substance – Cocaine, FTC with sentence</p> <p>Released:</p> <ul style="list-style-type: none">• Bail hearing on February 19th• Bail set, not met on February 19th• To be released on a Form 11 once residency is established• Remanded into custody until February 26th• Reside at named address• Remain in residence daily b/w the hours of 11pm and 6am• Next court date is February 26th

- Reside at named address
- Remain in residence daily b/w 9pm – 6am with **exceptions**

- Do not possess any weapons
- Next court date is February 27th






Charges: **STPS** – Theft under \$5000 x 3, FTC Probation x 2
APS - Possess property obtained by crime under \$5000 x 3, Identity theft, Identity fraud, B&E, Use of stolen credit card x 6

	<p>Charges: FTC release order x 2</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on February 20th• Guilty pleas to FTC with release order x 2• 10 days PSC• Remains in custody on outstanding charges
	<p>Charge: Assault – Spousal</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on February 20th• Guilty plea to assault• Conditional discharge• 12 months' Probation• Do not contact/communicate in any way direct/indirect by any means with named party• Do not attend 25m of any place the named party lives, works or goes to school with exceptions• Do not be within 25m of the named party with exceptions• Complete changing ways within 8 months of the order• Do not possess any weapons

	<p>Charges: Theft under \$5000 x 6, FTC Probation, FTC undertaking, Arson – Disregard for human life</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on February 20th• Guilty plea to lesser offence of Mischief from the original Arson charge, Theft under \$5000 x 3, FTC x 2• Time served; 120 days jail less PSC, equal to 80 days• 24 months' Probation• No contact/communication with named parties• Do not attend within 100m of any known place of residence, education or employment of the named parties• Do not attend named addresses• Remaining charges were withdrawn as part of the resolution
	<p>Charge: Arson</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on February 20th• Charge withdrawn by the Crown• No reasonable prospect of conviction – NRPC• Has outstanding matters before the court
	<p>Charges: Impaired over 80 BAC, FTC release order</p> <p>Disposition:</p> <ul style="list-style-type: none">• Court appearance on February 20th• Guilty pleas to both charges• \$1500 fine for the Over 80 BAC charge• \$10 fine for the FTC charge, taking into account 4 days of PSC• 1 year driving prohibition



Charges: FTC Undertaking, FTC Probation

Disposition:

- Court appearance on February 20th
- Guilty plea to FTC undertaking
- Suspended sentence
- 12 months' Probation
- No contact/communication with named party
- Do not attend at any known place of residence, employment or education of named party



Charges: Theft under \$5000 x 5 FTC release order

Disposition:

- Court appearance on February 21st
- Guilty plea to Theft under \$5000 & FTC
- Sentenced to 30 days jail less 15 days PSC (enhanced to 22 days) 8 days remaining to serve
- 12 months' Probation
- No contact/communication with named party
- Do not attend the named address
- Surrender property to Probation
- DNA
- Remaining charges were withdrawn as part of the resolution
