


# **COURT DISPOSITIONS**

## **Released:**







**Charge:** Assault with a weapon

#### Released:

- Bail hearing on January 31<sup>st</sup>
- Released on a Form 11
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not possess any weapons
- Attended court on February 1<sup>st</sup> and entered into a 12 months' Common Law Peace Bond (CLPB)
- Assault with a weapon charge withdrawn on Feb 1<sup>st</sup>
- Do not attend within 5m of the person of named person

## **Dispositions:**







**Charges:** FTC undertaking x 2, Assault police, Resist arrest, Utter threat to damage property

## **Disposition:**

- Court appearance on January 30th
- Guilty pleas to; Resist arrest, Utter threats
- Absolute discharge
- Remaining charges were withdrawn



**Charges:** Unauthorized possession of a prohibited weapon knowing it is unauthorized, Utter death threat, assault with a weapon, Trespass at night

## **Disposition:**

- Court appearance on January 30th
- Guilty plea to lesser charge; Unauthorized possess weapon
- Conditional Discharge, Elgin Therapeutic Court (ETC)
- 12 months' Probation
- No contact/communication with named parties
- Do not attend at any place of residence; employment or education of named parties
- S. 110 weapons prohibition order
- Remaining charges were withdrawn as part of the resolution



Charges: OPP - Assault BH, Assault, Mischief under \$5000, FTC Undertaking x 3

**STPS** – FTC Undertaking, FTC Probation x 3

#### **Disposition:**

- Court appearance on January 30<sup>th</sup>
- Guilty pleas to; FTC and Breach Probation
- 1 day deemed served with 46 days of PSC credited at 1.5:1 = 69days of pre-sentence custody (2 months and 9 days)
- 36 months' Probation
- No contact/communication with named party
- Non-attendance within 250m of any known place of residence, employment or education of named party
- Non-attendance within 25m of named party
- Successfully complete Changing Ways within the first 8 months of the Probation order
- No weapons
- DNA



Charge: Assault - Spousal

## **Disposition:**

- Court appearance on January 30<sup>th</sup>
- 12 months' CLPB
- No contact/communication with named party
- Non-attendance at any known place of residence, employment or education of named party
- Do not possess any weapons



**Charges:** Impaired operation, Over 80 BAC, Possess schedule I substance – Psilocybin, Having care/control of a m/v with Cannabis readily available

## **Disposition:**

- Court appearance on January 30<sup>th</sup>
- Guilty plea to Over 80 BAC
- \$1500 fine
- 1 year driving Prohibition
- Impaired operation was withdrawn by the Crown Possession of schedule I substance Psilocybin, and Having care/control of a m/v with cannabis readily available were previously withdrawn by the Federal prosecutor (PPSC)



**Charges:** Assault – Spousal, B&E x 2, Assault with a weapon, Assault BH, FTC release order x 10

### **Disposition:**

- Court appearance on January 31st
- All charges were stayed by the Crown



**Charges:** Possess property obtained by crime under \$5000, Theft under \$5000, FTC x 2

### **Disposition:**

- Sentenced to Penitentiary time on matters in the Niagara region. As a result there is no longer a public interest in pursuing the matters in St. Thomas
- STPS warrants were rescinded
- All STPS charges were withdrawn NPI



**Charges:** Assault – Spousal, Theft under \$5000 x 7, FTC release order, FTC Probation

### **Disposition:**

- Sentencing on February 1st
- Guilty pleas to the following; Theft under \$5000 x 4, FTC release order
- Sentenced to 60 days' jail
- 18 months' Probation
- Reside at named address
- Do not attend named locations
- 100 hours of community service



**Charges:** FTC Probation x 6, Theft under \$5000 x 2, Use of credit card x 3, FTC Undertaking, Possess property obtained by crime under \$5000 x 12

#### **Disposition:**

- Court appearance on February 1<sup>st</sup>
- Guilty pleas to the following; Possess property obtained by crime for purpose of trafficking, Breach Probation x 4, Possess Property obtained by crime under \$5000, Theft under \$5000 x 2, Use of credit card obtained by crime, FTC Undertaking
- 9 months jail (240 days) less PSC (222 days)
- 24 months' Probation
- Do not contact/communicate in any way, direct/indirect by any means with named party
- Do not attend within 50m of named party
- Do not enter named businesses
- Do not attend within 50m named addresses
- Do not possess any ID, card with data strip/security chip, debit, Credit card, cheque, unless it has been lawfully issued in name
