- Do not possess any drug paraphernalia
- Next court date is February 20th

- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Do not contact/communicate direct/indirect by any means with named party
- Do not attend any place the named party lives, works, attend schools or frequents
- Do not attend named location
- Do not possess any weapons
- Next court date is March 5th

Charges: B&E, FTC Probation

Disposition:

- Court appearance on February 13th
- All charges withdrawn by the Crown
- No reasonable prospect of conviction - NRPC



Charges: Assault, Utter threat BH

Disposition:

- Court appearance on February 13th
- All charges were withdrawn by the Crown
- The victim is not responding, no input from them
- Has outstanding charges before the court



Charges: Assault with a weapon, FTC release, FTC Probation x 2

Disposition:

- Court appearance on February 13th for sentencing
- Found guilty of assault with a weapon and FTC release order after trial on December 4th. Absconded from the court on sentencing date resulting in the bench warrant
- Sentenced to 120 days custody, less 12 days PSC; 108 days remaining to serve
- 18 months' Probation
- No contact/communication direct/indirect by any means with named party
- No weapons, 10 years prohibition
- DNA sample



Charges: Impaired operation, Over 80 BAC

Disposition:

- Court appearance on February 13th
- Guilty plea to Over 80 BAC
- \$2500 fine
- 12 months' driving Prohibition
- Impaired operation charge was withdrawn as part of the resolution



Charge: Impaired operation

Disposition:

- Court appearance on February 13th
- Charge withdrawn by the Crown due to medical reasons



Charges: Theft under \$5000 x 3

Disposition:

- Court appearance on February 13th
- Guilty plea to theft under \$5000 x 2
- 14 days sentence, 9 days of PSC = 14 days; 1 day deemed served
- 12 months' Probation Report as directed
- No contact or communicate with named party
- Do not attend at named addresses
- Perform 40 hours of community service
- Was released on a Form 11 for an assault charge before the court



Charges: **OPP** – FTC undertaking
APS – FTC Probation x 2, Assault, Theft under \$5000,
Robbery
STPS – FTC undertaking

Disposition:

- Court appearance on February 13th
- Guilty pleas to the following; Assault, Theft under \$5000
- Sentenced to a 90 day CSO
- 12 months' Probation House arrest with exceptions
- GPS monitoring while on CSO Probation 12 months
- No contact with named parties
- Non-attend within 100m of any known place of residence, employment, or education of named parties including named locations
- No weapons
- Pay restitution \$451.27 to named party
- Remaining charges were withdrawn as part of the resolution

Drive under suspension - HTA

Disposition:

- Court appearance on February 13th
- Guilty pleas to the following; Possession of property under \$5000, Prohibited operation
- Suspended sentence
- 12 months' Probation
- Do not contact/communication with named party
- 100 hours of community service
- 6 months' driving prohibition
- Remaining charges were withdrawn as part of the resolution
