Released:



Charges: OPP – Operate a conveyance in a dangerous manner **STPS** – Prohibited operation x 2

Released:

- Bail hearing on February 3rd
- Released on a Form 11
- Promise to pay \$250 if FTC with the release order
- Next court date is February 13th



Charge: B&E

Released:

- Bail hearing on February 4th
- Released on a Form 11
- Promise to pay \$250 if FTC with the release order
- Remain in his residence daily b/w 10pm 6am
- Do not attend within 10m of named address
- Do not possess any B&E tools
- Next court date is March 26th



Charges: Store firearm without lawful excuse, Possess firearm without being lawful owner, Occupy m/v knowing there was a handgun, Possess sched I substance for Trafficking x 6, Possess handgun without being lawful Owner, Possess prohibited weapon for dangerous Purpose, Possess weapon while prohibited, Operate conveyance while prohibited

Released:

- Bail hearing on February 5th
- Bail set, not met pending GPS ankle monitor
- Remain in custody until a GPS monitor is installed
- Promise to pay \$1,500 if FTC with release order
- Reside at named address
- Remain in residence at all times with exceptions
- Do not contact/communicate direct/indirect by any means with named parties
- Do not attend anywhere the named parties live, work, attend school
- Do not possess any weapons
- Do not possess any drug paraphernalia
- Next court date is February 26th

Charge: Sexual assault

- Court appearance for sentencing on February 5th
- Convicted of Sexual assault after trial on October 31st
- 90 days Intermittent jail sentence served on weekends
- 24 months' Probation, usual conditions
- Attend the EMDC sober on Fridays at 7pm until Sundays at 6pm until sentence is fully served
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not be within 5m of named party
- Do not attend any place the named party lives, works or attends school

Charges: Mischief under \$5000, Assault

Disposition:

- Court appearance on February 6th
- Guilty plea to assault
- Conditional discharge
- 12 months' of Probation
- No contact or communication with named party
- Do not attend named address
- Mischief charge was withdrawn as part of the resolution



Charge: Theft under \$5000

Disposition:

- Court appearance on February 6th
- Direct Accountability Program (DAP) completed
- Charge withdrawn



Charges: Mischief under \$5000, FTC Probation, FTC Undertaking, Possession of credit card obtained by crime, Possess property obtained by crime under \$5000

- Court appearance on February 6th
- DAP completed
- All charges were withdrawn by the Crown



Charge: Assault

Disposition:

- Court appearance on February 6th
- Mental Health Diversion completed
- Charge stayed



Charges: Robbery, Possession sched I substance – fentanyl, Mischief under \$5000

Disposition:

- Court appearance on February 6th
- Guilty pleas to the following; Robbery and Mischief
- 120 actual days, time served
- 18 months' Probation
- Do not attend named addresses
- No weapons
- Do not contact/communicate with named parties
- Do not attend within 10m of the person of named parties



Charge: Theft under \$5000

- Court appearance on February 6th
- Charge withdrawn as part of future global resolution with remaining criminal charges before the court



Charge: FTC Probation

Disposition:

- Court appearance on February 6th
- Charge withdrawn as part of future global resolution with outstanding charges before the court



Charges: Theft under \$5000 x 2

Disposition:

- Court appearance on February 6th
- Guilty plea to Theft under \$5000 x 1
- Suspended sentence
- 18 months' Probation
- Do not attend at named addresses
- Remaining charge withdrawn. Has HTA matters before PAO court



Charges: Assault, Carry a concealed weapon, Utter death threat, Assault with a weapon, FTC undertaking

- Court appearance on February 6th
- Deemed unfit to stand trial
- Remanded to the Southwest Centre for Forensic Mental Heath
- To have a hearing before the Ontario Review Board



Charge: Mischief

Disposition:

- Court appearance on February 7th
- Charge withdrawn
- No Public Interest NPI



Charge: Assault, Utter death threat

Disposition:

- Court appearance on February 7th
- Guilty plea to assault
- Conditional discharge
- Conditional sentence order for 12 months
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not possess any weapons
- Perform 20 hours of community service
- Remaining charge was withdrawn as part of the resolution



Charges: Utter death threat x 2, Assault, Careless use of a firearm

- Court appearance on February 7th
- Guilty pleas to the following; Utter death threat, Careless use of a firearm
- 12 months' Probation
- 40 hours of community service
- No contact or communication with named parties
- Do not attend any place you know the named parties live, work, attend school
- No intoxicants
- No weapons



Charges: Arson, FTC Probation x 2

Disposition:

- Court appearance on February 7th
- Guilty plea to Arson
- 18 months' Conditional sentence
- 24 months' Probation
- House arrest Reside at named address, First 6 months with
 exceptions Saturday 12-4pm to obtain the necessaries of life
- Last 12 months curfew 10pm-6am
- No alcohol or substance use
- Present at doorway
- No contact with any of the named parties
- Do not attend any place where the named parties are known to be
- Do not attend named address
- 100 hours community service
- No weaponsDNA
- s. 109 weapons prohibition (life)



Charges: Mischief under \$5000 x 2, Theft under \$5000 x 4, FTC Probation x 2, Assault police, Resist arrest, FTC

Disposition:

- Court appearance on February 8th
- Guilty pleas to the following; Mischief, Theft under x 2, Assault police, FTC undertaking
- Sentenced to 40 days enhanced to 60 days, 1 day deemed served
- 18 months' Probation
- Do not attend named addresses
- Do not possess any weapons



Charge: Theft under \$5000

- Court appearance on February 9th
- Charge withdrawn no public interest



Charges: Assault – Domestic, Mischief under \$5000 - Domestic

Disposition:

- Court appearance on February 9th
- Entered into a Peace Bond
- Charges withdrawn
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend any known place or residence, employment, education of named party
- Complete Changing Ways
- Do not possess any weapons



Charges: Assault – Spousal, FTC undertaking

- Court appearance on February 9th
- Entered into a 12 months' Peace Bond
- Charges withdrawn
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend within 50m of any known place of residence, employment or education of named party
- Do not possess any weapons
- Complete Changing Ways within the first 8 months of this order
