	<p><b>Charges:</b> <b>Bayham OPP</b> – Possess property obtained by crime over \$5000 x 5, Dangerous operation, Assault with a weapon, Fail to stop after accident, Prohibited operation, Theft under, FTC <b>STPS</b> – FTC release order</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing on March 2<sup>nd</sup></li><li>• Released on a Form 11</li><li>• Promise to pay \$200 if FTC with the release order</li><li>• Next court date is March 12<sup>th</sup></li></ul>

	<p><b>Charge:</b> Sexual Assault</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on March 7<sup>th</sup> for sentencing</li><li>• Sentenced to 5 months jail</li><li>• 2 years' Probation</li><li>• Do not contact/communicate in any way direct/indirect by any means with named party</li><li>• Do not attend within 25m of any place the named party is known to live, work, go to school</li><li>• No weapons</li><li>• SOIRA (10 years)</li><li>• DNA</li></ul>
