- Promise to pay \$1000 if FTC with the release order
- Report to the John Howard Society as directed
- Remain in residence between 9pm – 6am
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not attend within 25m of any place where the named parties live, work or attend school
- Do not attend within 25m of named address
- Do not possess any weapons
- Do not possess any ID, bank card, cheque or document unless it has been lawfully issued
- Next court date is April 9th








Charges: Sexual interference, Makes, prints, publish or possess for the purpose of publication, child pornography

Released:

- Bail hearing on April 5th
- Released on a Form 11
- Promise to pay \$2000 if FTC with the release order
- Reside at named address
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend any place where the named party lives, works or attends school
- Do not attend the City of St. Thomas
- Do not possess any weapons
- Do not attend any public park, public swimming area where persons under the age of 16 years are present or can reasonably be expected to be present
- Do not seek, obtain employment or continue any employment or become a volunteer in a capacity that involves being in a position of trust or authority towards persons under 16 years
- Do not have any contact, incl. communication by any means with a person who is under the age of 16 years
- Do not use the internet unless under the supervision of surety
- Next court date is April 23rd
