- Time served, 4 days of PSC enhanced to 6 days
- 12 months' Probation
- Do not attend within 25m of named address
- No weapons



Charge: Possession for the purpose of trafficking psilocybin

Disposition:

- Court appearance on April 23rd
- Entered into a 12 months' Common Law Peace Bond
- Keep the peace and be of good behaviour towards named parties

Charge: Assault

Charge: FTC Probation

Disposition:

- Mandated assessments, counselling and rehabilitation programs
- Do not have the care and custody of a child under the age of 16 unless authorized by F&CS



Charges: Impaired over 80 BAC, Drive under suspension, Novice Driver BAC above zero, Drive m/v without proper headlights, Drive m/v no validated permit, Fail to surrender insurance

Disposition:

- Guilty plea to Impaired over 80 BAC
- \$1600 fine
- 12 months' driving prohibition
- Remaining charges were withdrawn as part of the resolution

Charges: FTC Probation x 7, Possess property obtained by crime under \$5000 x 6, Identity theft, Use/deals/acts forged doc x 2, Obtain credit by false pretence, Theft over \$5000, Possess schedule I substance - Cocaine

Disposition:

- Court appearance on April 25th
- Guilty pleas to the following charges; Breach Probation x 2, Possess property obtained by crime under \$5000 x 3, Identity theft, Use/deals/acts on forged document
- Sentenced to 9 months jail sentence; less 84 days PSC
- Do not contact/communicate in any way direct/indirect with named parties
- Do not attend named addresses

- Do not attend within 50m of named location
- Do not possess any identification, debit or credit card, etc. unless lawfully issued
- 50 hours of community service
