- Guilty pleas to the following; Possess firearm, prohibited weapon x 1, FTC Probation x 2, Theft under \$5000
- Sentenced to 150 days; less 69 days PSC, has 81 days remaining on his sentence
- 2 years' Probation
- Do not attend at named addresses
- Do not possess any incendiary devices
