Charge: Aggravated assault

Released:

- Bail hearing on April 18th
- Released on a Form 11
- Promise to pay \$3000 if FTC with the release order
- Reside at named address
- Remain in residence daily b/w 10pm & 6am with exceptions
- Do not contact/communicate in any way direct/indirect by any means with all named parties
- Do not attend named address
- Do not possess any weapons
- Do not possess alcohol outside of residence
- Do not be under the influence of alcohol while outside of his residence
- Do not attend any establishments that's primary nature of business is the sale of alcohol
- Next court date is April 22nd






Charges: Theft under \$5000 x 3, Mischief under \$5000, FTC Probation

- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend named addresses
- Next court date is April 23rd

	<p>Charge: Sexual interference</p> <p>Disposition:</p> <ul style="list-style-type: none">• Jury trial scheduled for April 15th• Entered into a 3 year Common Law Peace Bond – CLPB to avoid scheduled trial• Do not contact/communicate with named party or any member of named party's immediate family• Do not be within 50m of any known place of residence, education or employment of named party or any member of their immediate family• Do not be within 50 m of the named party• Do not possess any weapons



Charges: Utter death threat, Assault with a weapon, FTC Probation

Disposition:

- Court appearance on April 16th
- Guilty plea to Utter death threat
- Sentenced to 60 days, 40 days PSC; time served
- 18 months' Probation
- Do not attend named address
- Do not attend within 25m named party
- Do not communicate with named party
- Do not possess any weapons
- Remaining charges were withdrawn
- Was turned over to London PS on a warrant



Charges: Assault with a weapon

Disposition:

- Court appearance on April 16th
- Charge withdrawn by the Crown
- Crown agreed the incident was consensual
- Has outstanding charges before the court
- Next court date is May 14th



Charges: Use of credit card x 3 Possess property under \$5000

Disposition:

- Court appearance on April 16th
- Guilty pleas to; Use of credit card
- Suspended Sentence
- 12 months' Probation
- Do not possess any debit/credit cards or financial instruments that are not in name
- 15 hours of community service
- \$100 victim surcharge fee
- Has an outstanding matter before the court



Charge: Assault

Disposition:

- Court appearance on April 16th
- Churchill entered into a 12 months' Peace Bond
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend any place named party lives, works or attends school
- Do not possess any weapons
- Charge withdrawn
- Has numerous outstanding charges before the court
- Next court date is May 7th



Charges: STPS - Impaired over 80 BAC

OPP - Refuse to provide breath sample, Theft under \$5000
B&E

Disposition:

- Court appearance on April 16th
- Guilty plea to Impaired driving
- Sentenced to 6 months' Conditional Sentence; 3 months on house arrest; 3 months on curfew with **exceptions**
- Wear a GPS monitoring device and be subject to the rules governing the device
- Do not purchase/consume/possess alcohol **except** to possess alcohol in the course of employment while on the conditional sentence
- 18 months' Probation
- Do not attend named address
- 40 hours of community service
- 2 year driving prohibition
- Remaining charges were withdrawn as part of the resolution



Charge: Cause a disturbance by swearing

Disposition:

- Court appearance on April 16th
- Charge withdrawn by the Crown
- NPI



Charge: Assault

Disposition:

- Court appearance on April 17, 2024
- Extra Judicial Sanctions (EJS) completed
- Charge withdrawn



Charges: Utter death threat, Sexual assault on person under 16 years, Sexual interference

Disposition:

- Court appearance on April 17th
- Charges were withdrawn by the Crown
- Has outstanding charges before the court
- Next court date is May 1st



Charges: Assault police, FTC Probation

Disposition:

- Court appearance on April 18th
- Charges withdrawn by the Crown
- No public interest – NPI



Charges: Impaired over 80 BAC, Careless driving

Disposition:

- Court appearance on April 19th
- Guilty plea to Careless driving
- \$1,000 fine
- 12 months' Probation
- Must have a zero BAC while operating a m/v
- Complete the Back on Track remedial program
- Over 80 BAC charge withdrawn



Charge: Theft over \$5000

Disposition:

- Court appearance on April 19th
- Charge withdrawn by the Crown
- NPI



Charge: Impaired over 80 BAC

Disposition:

- Court appearance on April 19th
- Guilty plea to lesser offence of Careless driving
- \$1,000 fine
- 12 months' Probation Provincial Offences Act
- Must have a zero BAC while operating a m/v
- Complete the Back on Track remedial driving
- Impaired driving charge was withdrawn as part of the resolution



Charges: Prohibited driving, Drive while under suspension, Careless driving, Fail to have insurance card

Disposition:

- Court appearance on April 19th
- Guilty plea to Careless driving, Drive under suspension – HTA
- \$2000 fine
- Remaining charges were withdrawn as part of the resolution
