	<p><b>Charges:</b> Assault carry weapon, Theft under \$5000, Identity theft</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing on March 26<sup>th</sup></li><li>• Released on a Form 11</li><li>• Promise to pay \$500 if FTC with the release order</li><li>• Report to the John Howard Society as directed</li><li>• Reside at named address and be amendable to the routine &amp; discipline or seek a bail variation with respect to address within 2 business days of any change in address</li><li>• Do not contact/communicate in any way direct/indirect by any means with all named parties</li><li>• Do not attend any place the named parties live, work or attend school</li><li>• Do not attend named addresses and locations</li><li>• Do not possess any weapons</li><li>• Do not possess any ID, card with data strip/security chip, debit/credit card, cheque unless lawfully issued in name</li><li>• Next court date is April 16<sup>th</sup></li></ul>
	<p><b>Charges:</b> Fraud under \$5000, x 2, Possess property obtained by crime under \$5000 x 2, Breach Probation x 3, Possess schedule I substance x 2</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing on March 27<sup>th</sup></li><li>• Released on a Form 11</li><li>• Promise to pay \$500 if FTC with the release order</li><li>• No contact/communication with named parties</li><li>• Do not attend at any place the named parties live, work, attend school, or happen to be</li><li>• Do not possess any ID, card with data strip/security chip, debit/credit card, cheque unless lawfully issued</li><li>• Next court date is April 8<sup>th</sup></li></ul>

	<p><b>Charges:</b> Sexual assault, Sexual Interference, Assault with a weapon</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on March 25<sup>th</sup> for judgment and sentencing</li><li>• Found guilty of Assault with a weapon and not guilty of Sexual assault, and Sexual interference</li><li>• Conditional discharge</li><li>• 12 months' Probation, usual conditions</li><li>• Do not contact/communicate in any way direct/indirect by any means with named parties</li><li>• Do not be within 100m of any place the named parties live, work or attend school</li><li>• Do not possess any weapons</li></ul>
	<p><b>Charges:</b> Possession of a weapon for a dangerous purpose, Carry a concealed weapon, Assault police, Cause a disturbance</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Fitness hearing court appearance on March 25<sup>th</sup></li><li>• Deemed unfit to stand trial</li><li>• Remanded to EMDC until a bed is available at the Southwest Centre for Forensic Mental Health St. Thomas</li><li>• To appear before the Ontario Review Board when deemed fit</li></ul>
	<p><b>Charge:</b> Theft under \$5000</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on March 26<sup>th</sup></li><li>• Direct Accountability Program completed</li><li>• Charge withdrawn</li></ul>

	<p><b>Charges:</b> Unauthorized possession of a prohibited weapon, Resist arrest, FTC Probation, Possession for the purpose of trafficking x 2 (Fentanyl &amp; Cocaine)</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Court appearance on March 26<sup>th</sup></li> <li>• Charges withdrawn except for the CDSA matters</li> <li>• CDSA charges transferred to Federal court – PPSC</li> <li>• Next court date is April 8<sup>th</sup></li> </ul>
	<p><b>Charges:</b> Assault with a weapon, Mischief under \$5000, Arson</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"> <li>• Court appearance via Zoom from CNCC, Penetanguishene on March 26<sup>th</sup></li> <li>• Guilty pleas to the following; Mischief under \$5000, lesser charge of Arson by negligence</li> <li>• 2 years' Penitentiary jail sentence requested for counselling services</li> <li>• No contact/communication with named parties</li> <li>• s. 110 Order, DNA order</li> </ul>



**Charges:** Criminal harassment, Harassing phone calls, FTC Undertaking x 2

**Disposition:**

- Court appearance on March 26<sup>th</sup>
- Guilty pleas to; Harassing calls, FTC x 2
- Suspended sentence
- 2 years' Probation
- No contact with named parties
- Do not attend within 100m of any known place of residence, employment or education of named parties
- No weapons
- Has outstanding charges before the court
- Next court date is April 16<sup>th</sup>

**Disposition:**

- No reasonable prospect of conviction – NRPC
- The victim will not cooperate
- Charges withdrawn

- Charge withdrawn

	<p><b>Charges:</b> Over 80 BAC, Drive m/v cannabis readily available, Fail to surrender permit, Fail to surrender insurance card</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on March 26<sup>th</sup></li><li>• Guilty plea to Over 80 BAC</li><li>• \$3900 fine</li><li>• 1 year driving Prohibition</li></ul>
	<p><b>Charge:</b> Public mischief</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on March 26<sup>th</sup></li><li>• Entered into a 12 month' Common Law Peace Bond – CLPB</li><li>• Keep the peace and be of good behavior generally and specifically towards named party</li><li>• Charge withdrawn</li></ul>

**Disposition:**

- Guilty plea to Over 80 BAC
- \$1500 fine
- 12 months' driving Prohibition



**Charge:** Assault

**Disposition:**

- Court appearance on March 27<sup>th</sup>
- Entered into a 12 months' CLPB
- Keep the peace and be of good behaviour generally and specifically towards named party
- Do not attend any place named party lives, works, or attends school
- Assault charge was withdrawn



**Charges: STPS** - Drive under suspension x 2, Operate m/v without insurance, Use plate not authorized for m/v  
**OPP** – Drive under suspension x 2, Obstruct plate x 2, Use plate not authorized x 3, Drive m/v without insurance x 3, Fail to surrender permit for m/v x 2, Colour coating obscuring interior, Race a m/v, Fail to apply for permit, Fail to change address

**Disposition:**

- Guilty pleas to the following; Race a m/v, Drive under suspension x 5, Drive m/v no insurance x 2, Use plate not authorized for m/v x 2, Fail to surrender permit for m/v
