• Released on a Form 11

Report to the John Howard Society as directed

<ul> <li>Released:</li> <li>Bail hearing on May 1<sup>st</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$500 if FTC with the release order</li> <li>Reside at named address</li> <li>Do not contact/communicate in any way with named party</li> <li>Do not be within 25m of any place the named party lives, works or attends school incl. named address</li> <li>Do not be within 25m of named party</li> <li>Do not be within 25m of named party</li> <li>Do not attend named location</li> <li>Do not possess any weapons</li> <li>Arrested on May 2<sup>nd</sup> for breach and remanded into custody until May 6<sup>th</sup> for a bail hearing</li> </ul>
<ul> <li>Charges: Possess sched I substance for trafficking – Meth, Oxycocet, fentanyl, Possess prohibited weapon, Possess property obtained by crime under \$5000 x 7, Breach Probation, FTC x 4</li> <li>Released: <ul> <li>Bail hearing on May 1<sup>st</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$1000 if FTC with the release order</li> <li>Reside at named address</li> <li>Do not contact/communicate direct/indirect by any means with named parties</li> <li>Do not be within 25m of named parties</li> <li>Do not attend named address</li> <li>Do not possess any weapons</li> <li>Next court date is May 27<sup>th</sup></li> </ul> </li> </ul>
<ul> <li>Charge: Assault</li> <li>Released: <ul> <li>Bail hearing on May 2<sup>nd</sup></li> <li>Released on a Form 11</li> <li>Promise to pay \$250 if FTC with the release order</li> <li>Do not contact/communicate in any way direct/indirect by any means with named party</li> <li>Do not attend named address</li> <li>Next court date is May 7<sup>th</sup></li> </ul> </li> </ul>

## **Dispositions:**

<ul> <li>Charges: Assault – Spousal, Mischief under \$5000 - Spousal</li> <li>Disposition: <ul> <li>Court appearance on April 29<sup>th</sup></li> <li>Charges withdrawn by the Crown</li> <li>No reasonable prospect of conviction – NRPC</li> <li>The victim would not provide a statement or cooperate with the Crown</li> </ul> </li> </ul>
<ul> <li>Charges: Assault – Spousal, Arson, FTC, Mischief under \$5000, Careless storage or ammunition</li> <li>Disposition: <ul> <li>Court appearance on April 30<sup>th</sup></li> <li>Guilty plea to; Careless storage of ammunition</li> <li>Sentenced to 30 days, 20 days PSC enhanced to 30 days</li> <li>18 months' Probation</li> <li>No contact or communication with named party</li> <li>Do not attend within 50m of named address</li> <li>Do not possess any incendiary devices except for 1 lighter to use for lighting cigarettes/or legal smoking substances</li> <li>Assault charge was withdrawn by the Crown - NRPC</li> <li>Remaining charges were withdrawn as part of the resolution</li> </ul> </li> </ul>
<ul> <li>Charges: Breach of Conditional sentence x 2</li> <li>Disposition: <ul> <li>Court appearance on April 30<sup>th</sup></li> <li>Guilty plea x 2</li> <li>Sentenced to 15 months jail, less 59 days PSC</li> </ul> </li> </ul>

<b>Charges:</b> Assault police with a weapon, FTC Probation x 2
Disposition:
<ul> <li>Court appearance on April 30<sup>th</sup></li> </ul>
<ul> <li>Guilty plea to lesser offence; Obstruct police</li> </ul>
<ul> <li>20 days of pre-plea custody applied equivalent to 30 days jail</li> </ul>
<ul> <li>No probation sought</li> </ul>
<ul> <li>Remaining charges were withdrawn as part of the resolution</li> </ul>
<b>Charges:</b> FTC Probation x 6, Theft under \$5000, Personation with intent, Possess property obtained by crime under \$5000
Disposition:
• Court appearance on April 30 <sup>th</sup>
<ul> <li>Guilty pleas to the following; Personation with intent, Breach</li> </ul>
Probation
<ul> <li>15 days jail - 10 days of PSC; time served</li> </ul>
• 12 months' Probation
Do not attend named addresses
• Do not contact named party, non-attendance at any known place
of residence, employment or education of named party
• Do not possess banking/cards/etc. not lawfully issued

Disposition:
• Court appearance on April 30 <sup>th</sup>
• Guilty plea to; Possess property obtained by crime under \$5000
• 90 day Conditional Sentence - house arrest for duration with
 exceptions
Wear a GPS monitoring device
Reside at named address
• Do not purchase, possess, or consume alcohol or cannabis
No contact with named party
• Do not attend within 100m of any known place of residence,
education or employment of named party

<ul> <li>Charges: B&amp;E, Possess B&amp;E tools, Obstruct police, FTC</li> <li>Disposition: <ul> <li>STPS charges were transferred to London court</li> <li>Global resolution with London PS charges</li> <li>15 months jail sentence</li> <li>24 months' Probation</li> <li>Do not possess any weapons or B&amp;E tools</li> <li>Do not have care or control of a m/v not registered in name</li> <li>100 hours of community service</li> <li>DNA</li> <li>12 months' driving prohibition</li> <li>Restitution order; Payee 1:\$12,499, Payee 2 \$15,899</li> </ul> </li> </ul>
