- Promise to pay \$500 if FTC with the release order
- Reside with surety
- Do not contact/communicate in way direct/indirect by any means with named parties
- Do not attend any place the named parties live, work or go to school
- Do not possess any weapons
- Do not occupy the driver's seat of a m/v
- Next court date is June 11th



Charges: Mischief under \$5000, Obstruct police, Assault x 2

Released:

- Bail hearing on May 9th
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Reside at named address
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not attend any place the named parties lives, works, or goes to school
- Do not possess any weapons
- Next court date is May 24th



Charges: Cultivate, propagate or harvest more than four plants, Possess cannabis for purpose of selling, Possess sched 1 substance for trafficking – Meth, Hydromorphone, Cocaine, Possess property under \$5000, Possess imitation weapon dangerous to the public, Possess while prohibited, Laundering proceeds of crime

Released:

- Reside with surety
- Remain in residence daily b/w 10pm and 6am with exceptions

Disposition:

- Court appearance on May 7th

- \$2600 fine
- 12 months' driving prohibition
- Remaining charge was withdrawn



Charge: Assault

Disposition:

- Court appearance on May 7th
- 12 months' Common Law Peace Bond (CLPB)
- Charge was withdrawn as part of the resolution
- No contact with named party
- Non-attendance at any known place of residence, employment or education of named party
- Contact Changing Ways and successfully complete the program
- No weapons



Charges: Theft under \$5000, Assault – Spousal, FTC x 2, FTC Probation

Disposition:

- Court appearance on May 7th
- Guilty plea to FTC undertaking
- 5 days of PSC imposed - treated at 8 days jail
- Existing Probation order left in place



Charge: Assault - Spousal

- No reasonable prospect of conviction - NRPC



Charge: Theft under \$5000

Disposition:

- Charge withdrawn by the Crown
- Direct Accountability Program - DAP completed

- Court appearance on May 7th
- Charge withdrawn by the Crown
- DAP completed



Charges: Disqualified driving – CCC, Drive m/v in contravention of conditions - HTA

Disposition:

- Court appearance on May 7th
- Guilty plea to Drive m/v in contravention of driver's permit
- \$850 fine
- Criminal charge was withdrawn



Charges: Mischief – Spousal , Utter death threat - Spousal

Disposition:

- Court appearance on May 7th
- Entered into a 12 months' Peace Bond
- Charges withdrawn
- No contact with named party
- Complete Changing Ways
- Do not possess any weapons
- Has outstanding criminal charges before the court



Charges: Assault with a weapon, Dangerous operation, Flight from police

Disposition:

- Video court appearance on May 7th
- Guilty plea to Assault with a weapon
- Conditional discharge
- Reside at named address
- 2 years' Probation
- 80 hours community service
- Do not possess or use and products containing THC



Charge: Breach of conditional sentence order

Disposition:

- Court appearance on May 7th
- Guilty plea
- 16 pays PSC; time served
- Conditional sentence order is complete



Charge: FTC undertaking, Disobey court order

Disposition:

- Court appearance on May 7th
- Guilty plea to Disobey court order
- Time served; held for WASH court after the arrest - 1 day overnight enhanced to 2
- \$200 fine
- Remaining charge was withdrawn



Charges: Possess of firearm while prohibited x 5, FTC Probation x 3, Use of firearm while committing designated offences, FTC release order x 2, Point firearm, Possess of weapon for a dangerous purpose, Unauthorized possession of a firearm, FTC undertaking, Assault with a weapon, B&E

Disposition:




- Scheduled trial avoided on May 8th
- Guilty plea to the following; Possession of firearm while prohibited, FTC release order x 2, FTC Undertaking, FTC Probation, B&E, Assault with a weapon
- Sentenced to 730 days jail, 330 days enhanced to 495 days. Has 235 days remaining on his sentence
- Followed by 3 years' Probation
- Numerous non associations, do not attend locations
- Remaining charges were withdrawn as part of the resolution



Charges: Mischief under \$5000 x 2

Disposition:

- Court appearance on May 9th
- Entered into a 2 years' CLPB
- Restitution paid to the victims
- No contact/communication with named parties
- Do not attend within 100 meters of any place the named parties live, work or go to school or are known to be
- Do not attend within 50m of named addresses
- Charges withdrawn as part of the resolution
