
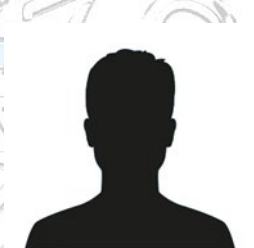

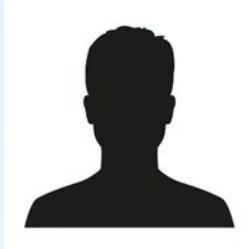

- Next court date is May 28<sup>th</sup>



**Charges:** Criminal harassment, B&E, FTC undertaking

**Released:**

- Bail hearing on May 15<sup>th</sup>
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not be within 50m of any place the named party lives, works or attends school
- Do not possess any weapons
- Do not possess any licences to acquire or purchase any firearms
- Next court date is June 4<sup>th</sup>



**Charges:** FTC Probation x 2

**Released:**

- Bail hearing on May 15<sup>th</sup>
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Report to the John Howard Society as directed
- Do not contact/communicate in any way by any means with named party
- Do not be within 50m of any place the named party lives, works or attends school, incl. named address
- Next court date is May 28<sup>th</sup>

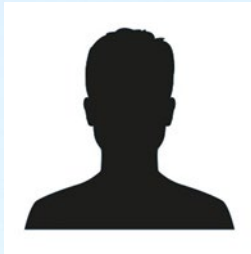


**Charges:** Criminal harassment x 2, Harassing phone calls x 2, Utter threats bodily harm x 2, FTC undertaking

**Released:**

- Bail hearing on May 16<sup>th</sup>
- Released on a Form 11
- Promise to pay \$250 if FTC with the release order
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not attend within 50m of any place the named parties live, work, attend school
- Do not possess any weapons
- Next court date is June 4<sup>th</sup>

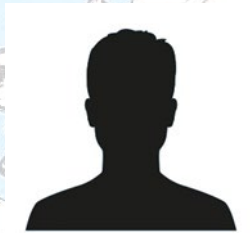




**Charge:** FTC Probation

**Released:**

- Bail hearing on May 16<sup>th</sup>
- Promise to pay \$500 if FTC with the release order
- Report to the John Howard Society as directed
- Reside at named address
- Notify STPS OIC of any change in address within 24hrs
- Next court date is June 4<sup>th</sup>






**Charge:** Assault

**Released:**

- Bail hearing on May 17<sup>th</sup>
- Released on a Form 11
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not be within 50m of any place the named party lives, works, attends school, frequents or is known to be
- Access to children arranged through F&CS
- Do not possess any weapons
- Next court date is June 18<sup>th</sup>

	<p><b>Charges:</b> Breach Probation, Assault BH</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on May 14<sup>th</sup></li><li>• Guilty plea to Breach Probation</li><li>• Sentenced to 4 days PSC enhanced to 7 days jail; time served</li><li>• Assault BH charge withdrawn</li><li>• Has outstanding HTA charges before the court scheduled for July 10<sup>th</sup></li></ul>
	<p><b>Charges:</b> Dangerous operation x 2, Stunt driving x 4, Drive disqualified x 2, Possess for purpose – cocaine, Resist police, Operate m/v no insurance, Obstruct plate</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on May 14<sup>th</sup></li><li>• Guilty plea to the following; Dangerous operation, Stunt driving, FTC release order, Drive no insurance</li><li>• Suspended sentence</li><li>• 18 months' Probation</li><li>• 60 hours of community service</li><li>• 12 month driving prohibition</li><li>• \$10,000 fine for the following offences; Operate m/v no insurance, stunt driving, CDSA</li><li>• Remaining charges were withdrawn as part of the resolution</li></ul>

**Charges:** Disqualified driving, Fail to show insurance card,  
Fail to surrender permit

**Disposition:**

- Court appearance on May 14<sup>th</sup>
- Guilty plea to Disqualified driving
- 60 conditional sentence to be served on house arrest with GPS monitoring with usual exceptions
- No drugs, no alcohol etc.
- 1 year driving prohibition



**Charge:** Theft under \$5000

**Disposition:**

- Court appearance on May 14<sup>th</sup>
- Direct Accountability Program – DAP completed
- Charge withdrawn by the Crown



**Charges:** Prohibited operation x 2, Possess property obtained by  
Crime under \$5000, FTC release order, FTC Probation x 3,  
Theft under \$5000, Drive under suspension - HTA

**Disposition:**

- Court appearance on May 14<sup>th</sup>
- Guilty plea to Disqualified driving, Possession of property obtained by crime under \$5000
- 60 days jail - 40 days of PSC applied; time served
- 12 months' Probation
- 1 year driving prohibition
- Do not contact/communicate in any way direct/indirect with named party
- Do not be within 100m of any place named party lives, works, attends school
- Do not possess or consume alcohol or other intoxicating substances, unlawful drugs etc.
- Remaining charges were withdrawn as part of the resolution





**Charge:** Assault - Spousal

**Disposition:**

- Court appearance on May 14<sup>th</sup>
- Charge was withdrawn by the Crown
- No reasonable prospect of conviction – NRPC



**Charges:** Possession of a firearm or ammunition contrary to Prohibition order x 4

**Disposition:**

- Court appearance on May 14<sup>th</sup>
- Charges withdrawn by the Crown



**Charges:** Criminal harassment, FTC release order

**Disposition:**

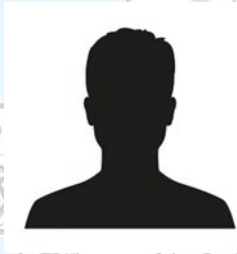
- Court appearance on May 14<sup>th</sup>
- Changing Ways completed
- Charges were withdrawn by the Crown
- Has two remaining occurrences before the court



**Charge:** Assault

**Disposition:**

- Court appearance on May 14<sup>th</sup>
- Entered into a 12 months' CLPB
- No contact with named party; do not attend at named address.
- Charge was withdrawn by the Crown as part of a resolution of multiple accused parties



**Charges:** Impaired driving, Operate m/v with liquor readily available, Operate m/v no insurance

**Disposition:**

- Court appearance on May 15<sup>th</sup>
- Guilty plea to Operate m/v with liquor available
- \$250 fine
- Remaining charges were withdrawn



**Charge:** Assault with a weapon

**Disposition:**

- Court appearance on May 15<sup>th</sup>
- Entered into a 12 months' CLPB
- Do not contact/communicate/associate in any way direct/indirect by any means with named parties
- Do not attend at any place the named parties live, work, go to school
- Do not attend at named address
- Do not possess any weapons

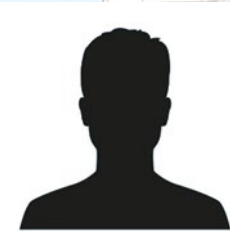




**Charges:** Flight from police - CCC  
Drive m/v no licence, Fail to stop for police - HTA

**Disposition:**

- Court appearance on May 15<sup>th</sup>
- Guilty plea to both HTA charges
- \$400 fine
- 2 years' driving prohibition



**Charges:** Utter death threat, FTC undertaking

**Disposition:**

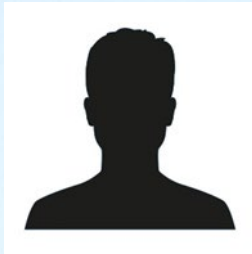
- Court appearance on May 15<sup>th</sup>
- Charges withdrawn by the Crown
- NRPC



**Charges:** Possession of property obtained by crime, FTC x 4

**Disposition:**

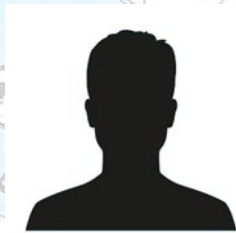
- Court appearance on May 15<sup>th</sup>
- Guilty pleas to the following; Possess property obtained by crime under \$5000, FTC x 2
- Non associate/communicate as directed by Probation
- 18 months' Probation
- Do not possess any weapons
- Remaining charges were withdrawn as part of the resolution



**Charge:** Assault – Spousal

**Disposition:**

- Court appearance on May 15<sup>th</sup>
- Charge withdrawn
- Entered into a 12 months' CLPB
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend at any place the named party lives, works, attends school



**Charges:** Unlawfully in a dwelling, Assault

**Disposition:**

- Court appearance on May 17<sup>th</sup>
- Entered into a 12 months' CLPB
- Charges withdrawn
- Keep the peace and be of good behaviour specifically toward named party



**Charges:** Assault – Spousal, S. 810 Peace bond

**Disposition:**

- Court appearance on May 17<sup>th</sup>
- Entered into a 12 months' CLPB
- S. 810 charge stayed
- Participate in and successfully complete the Changing Ways Program in 8 months
- No contact with named party
- Non-attendance at any known place of residence, employment or education of the named party
- No weapons
- Assault charge was withdrawn as part of the resolution



**Charge:** Sexual assault, Sexual interference

**Disposition:**

- Sentencing for guilty plea to sexual interference on May 17<sup>th</sup>
- Sentenced to 15 months jail
- 3 years' Probation
- DNA sample
- 109 weapons prohibition order
- s. 161 order (up to life - schools, parks, employment, communicating via compute etc)
- s. 743.21 Non-Communication Order
- Sexual assault charge was withdrawn as part of the resolution



**Charges:** ABH – Choking, Mischief – Domestic x 4, Dangerous operation, Intimidation Justice system, Assault with a weapon – Spousal x 2, FTC release order x 3, Obstruct police, Fraud under \$5000, Possess property obtained by crime under \$5000

**Disposition:**

- Court appearance on May 17<sup>th</sup>
- Guilty pleas to the following; FTC, Mischief x 2, Lesser offence of assault, obstruct police
- 1 day deemed served; 96 actual days enhanced to 144 days
- 24 months' Probation with terms
- No contact with named parties
- Do not attend within 100m of any known place of residence, employment or education of named parties
- Do not be within 25m of the named party
- Successfully complete Changing Ways program in 8 months
- No weapons
- Do not attend within the City of St. Thomas for the first 6 months of the order
- Probation order being transferred to Lambton
- DNA taken today
- Remaining charges were withdrawn as part of the resolution
