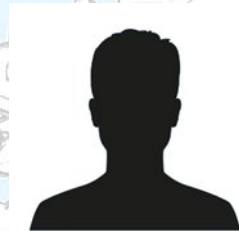
	<p><b>Charges:</b> Aggravated assault, Assault with a weapon, FTC release order</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing on June 7<sup>th</sup></li><li>• Released on a Form 11</li><li>• Promise to pay \$1000 if FTC with the release order</li><li>• Reside at named address</li><li>• Notify STPS OIC of change in address within 24 hours</li><li>• Remain in residence daily b/w 10pm and 6am</li><li>• Do not contact/communicate in any way direct/indirect by any means all named parties</li><li>• Do not be within 100m of any place the named parties live, work or attend school</li><li>• Do not attend within 25m of named parties</li><li>• Do not possess any weapons</li><li>• Next court date is July 16<sup>th</sup></li></ul>
	<p><b>Charges:</b> Mischief, FTC</p> <p><b>Released:</b></p> <ul style="list-style-type: none"><li>• Bail hearing on June 8<sup>th</sup></li><li>• Released on a Form 11</li><li>• Promise to pay \$200 if FTC with the release order</li><li>• Next court date is June 25<sup>th</sup></li></ul>



**Charges:** Mischief, Assault with a weapon - Spousal

**Released:**

- Bail hearing on June 10<sup>th</sup>
- Released on a Form 11
- Promise to pay \$500
- Notify STPS OIC of change in address within 24 hours
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not be within 25m of any place the named parties live, work, go to school or frequent
- Do not attend named address
- Do not possess any weapons
- Next court date is June 18<sup>th</sup>



**Charge:** FTC release order

**Released:**

- Bail hearing on June 11<sup>th</sup>
- Charge withdrawn by the Crown
- No reasonable prospect of conviction – NRPC
- Did not breach condition



**Charges:** Impaired operation, Possess schedule I substance – Fentanyl  
FTC release order

**Released:**

- Bail hearing on June 13<sup>th</sup>
- Released on a Form 11
- Promise to pay \$250 if FTC with the release order
- Next court date is June 18<sup>th</sup> to plead guilty to outstanding charges






**Charges:** Theft under \$5000, Possess property under \$5000,  
Possess schedule I substance - Meth

**Released:**

- Bail hearing on June 13<sup>th</sup>
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Do not attend named location
- Next court date is June 25<sup>th</sup>

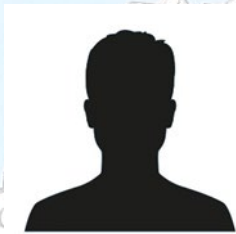
	<p><b>Charges:</b> Sexual assault, Assault</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Trial scheduled for June 10<sup>th</sup></li><li>• Guilty plea to assault on 1<sup>st</sup> day of trial</li><li>• Suspended sentence</li><li>• 18 months' Probation</li><li>• Reside at named address</li><li>• No contact/communication with named party</li><li>• Do not attend any place the named party lives, works or attends school</li><li>• Do not be within 25m of the named party</li><li>• No weapons</li></ul>
	<p><b>Charges:</b> Forcible confinement, Assault – Spousal, FTC Probation x 4</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on June 10<sup>th</sup></li><li>• Entered into a 24 months' Common law peace bond</li><li>• Do not contact/communicate in any way direct/indirect by any means with named party</li><li>• Do not attend at any place where the named party is known to live, work or attend school</li><li>• Do not possess any weapons</li><li>• Remaining charges were withdrawn as part of the resolution</li></ul>
	<p><b>Charges:</b> APS – Possess property obtained by crime under \$5000 STPS – Theft under \$5000</p> <p><b>Disposition:</b></p> <ul style="list-style-type: none"><li>• Court appearance on June 11<sup>th</sup></li><li>• Direct Accountability Program – DAP completed</li><li>• Charges withdrawn by the Crown</li></ul>



**Charges:** Utter forged document x 4

**Disposition:**

- Court appearance on June 11<sup>th</sup>
- DAP completed
- Charges withdrawn by the Crown



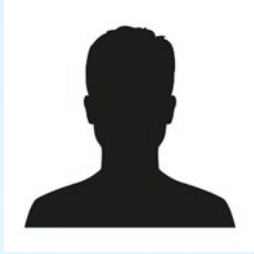
**Charges: OPP – B&E steals firearm**

**APS - B&E**

**STPS – Assault x 2, Possess property over \$5000, Utter forged document, Fraud under \$5000**

**Disposition:**

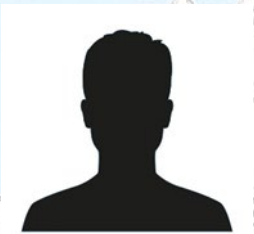
- Court appearance on June 11<sup>th</sup>
- Guilty plea to lesser charge of B&E from the B&E - steals firearm charge
- Custody for a period of 150 days less 86 enhanced days of PSC, 64 days remaining to serve
- 2 years' Probation
- No contact/communication with named party
- Do not attend any known place of residence, education or employment of named party
- 12 months' CLPB on the Assault x 2 charges
- No contact/communication with named parties
- Do not attend within 100m of any known place of residence, education or employment of the named parties
- Do not possess any weapons
- DNA
- Remaining charges were withdrawn
- APS – B&E charge, Identification was not clear enough - NRPC



**Charges:** Breach of conditional sentence order, Breach Probation

**Disposition:**

- Court appearance on June 11<sup>th</sup>
- Conditional sentence collapsed - balance of sentence to be served in custody
- Breach Probation charge was withdrawn, Probation order would have been suspended while on the CSO



**Charges:** Assault x 2, Utter threat bodily harm x 2

**Disposition:**

- Court appearance on June 11<sup>th</sup>
- Guilty pleas to the following; Utter threat bodily harm x 2, assault
- Suspended sentence
- 2 years' Probation
- No contact/communication with named parties
- Do not attend at any known place of residence, education or employment of named parties
- Do not be within 25m of the named person
- Do not possess any weapons
- DNA sample



**Charges:** Theft under \$5000 x 4, Possess B&E tools, B&E, Mischief, Dangerous operation x 2, Flight from police x 2, Prohibited operation, Theft over \$5000 of a m/v, Suspended driving x 2, Fail to remain - HTA

**Disposition:**

- Court appearance from CNCC jail on June 12<sup>th</sup>
- Guilty pleas to the following; Theft under \$5000, B&E, Dangerous operation, Disqualified drive, Theft over \$5000
- 6 months custody, global sentence
- 2 years' Probation
- Do not attend the list of named locations
- No contact or communication with named parties
- Do not attend within 50 m of any known place of residence, education or employment of named parties
- Complete 240 hours community service
- Do not possess any weapons
- 3-year driving prohibition
- DNA
- s. 110 weapons prohibition (5 years)



**Charges:** Assault – Spousal x 4, Assault, Utter death threat

**Disposition:**

- Court appearance on June 13<sup>th</sup>
- Guilty plea to Assault, Utter death threat
- Conditional discharge
- 12 months' Probation
- No communication/contact with named party
- Non-attendance within 100m of any known place of residence, employment or education of named party
- No contact with named party
- Non-attendance at any known place of residence, employment, or education of named party
- Complete Changing Ways within 8 months
- No weapons



**Charges:** Impaired operation, Over 80 BAC

**Disposition:**

- Court appearance on June 13<sup>th</sup>
- Guilty plea to Over 80 BAC
- \$2600 fine
- 12 months' driving Prohibition
- Impaired charge withdrawn as part of the resolution



**Charge:** Assault

**Disposition:**

- Court appearance on June 14<sup>th</sup>
- Mental health diversion completed
- Charge stayed



**Charges:** Assault – Spousal, FTC release order x 3

**Disposition:**

- Court appearance on June 14<sup>th</sup>
- Entered into a 12 months' CLPB
- No contact with named party
- Non-attendance within 100m of any known place of residence, employment or education of named party
- Complete Changing Ways Program within 8 months
- No weapons
- Charges withdrawn
