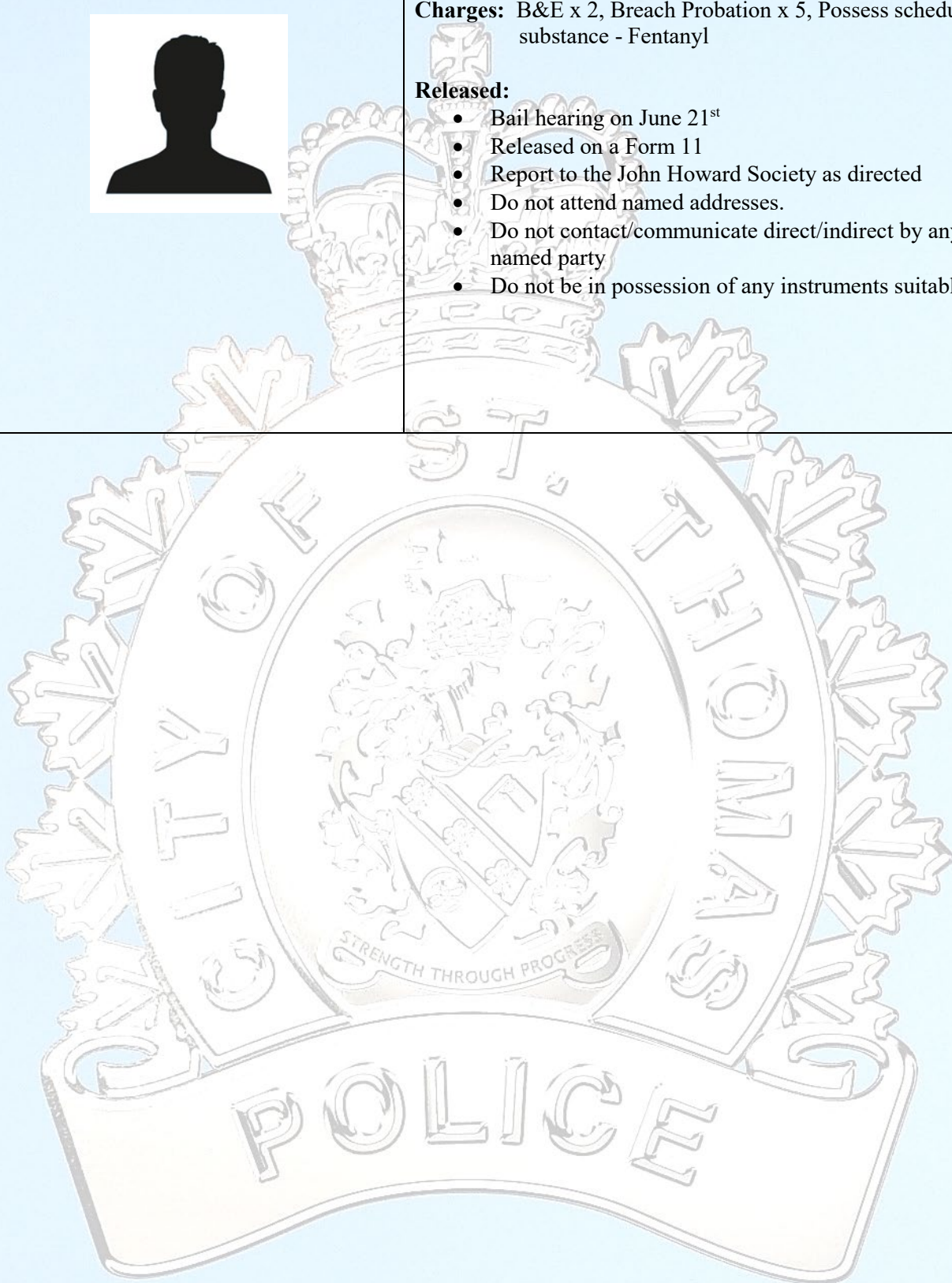




Charges: B&E x 2, Breach Probation x 5, Possess schedule I substance - Fentanyl

- Do not attend named addresses.
- Do not contact/communicate direct/indirect by any means with named party
- Do not be in possession of any instruments suitable for B&E's

Charge: Assault BH

Disposition:

- Court appearance on June 18th
- Charge withdrawn by the Crown
- No reasonable prospect of conviction – NRPC
- Has numerous HTA matters before the court



Charge: Over 80 BAC

Disposition:

- Court appearance on June 18th
- Guilty plea to Dangerous operation
- \$1000 fine
- 12 months' driving prohibition



Charges: STPS – Prohibited driving
OPP - Over 80 BAC, Prohibited driving

Disposition:

- Court appearance on June 18th
- Guilty pleas to Over 80 BAC and Prohibited driving
- Sentenced to 90 days jail
- 3 years' driving prohibition
- 1 year probation

POLICE



Charges: FTC Probation x 6, Use of credit card x 3, Theft under \$5000, Possess property obtained by crime under \$5000 x 2, Theft from m/v, Trespass at night

Disposition:

- Court appearance on June 18th
- Guilty pleas to the following; Use of credit card, Trespass at night, FTC Probation
- 92 days of PSC (the equivalent of 138 days jail); 42 more days imposed on each offence
- 12 months' Probation
- Do not attend named locations
- No contact/communication with named parties
- Do not attend any place the named parties live, work or go to school
- Do not possess any bank card, credit card etc. not lawfully issued
- Remaining charges were withdrawn as part of the resolution



Charges: Posses schedule I substance – Meth & Cocaine

Disposition:

- Court appearance via Zoom on June 18th
- Guilty plea to the Cocaine charge
- Sentenced to 2 years' Probation
- Perform 75 hours of community service



Charges: Mischief x 2, Theft under \$5000, FTC Probation x 4, FTC release order x 3, B&E x 2, Possess B&E tools, Resist police, Assault police

Disposition:

- Court appearance on June 18th
- Guilty pleas to the following; Theft under \$5000, FTC x 3, B&E x 2
- 4 months jail (part of total sentence of 285 days in jail) - has 86 days of PSC - enhanced to 129 days, leaving 156 days to be served
- 12 months' Probation
- Do not attend named locations
- Do not possess break and enter tools
- Perform 10 hours of community service
- Remaining charges were withdrawn as part of the resolution



Charges: Assault – Spousal, FTC Probation x 3, FTC undertaking x 4

Disposition:

- Court appearance on June 18th
- Guilty pleas to the following; FTC Probation and FTC undertaking
- 27 days of PSC, enhanced to 41 days - 1 day deemed served
- 12 months' Probation
- No contact with named party
- Do not attend at any known place of residence, employment or education of named party
- Do not possess any weapons
- Remaining charges were withdrawn



Charges: FTC Probation x 2

Disposition:

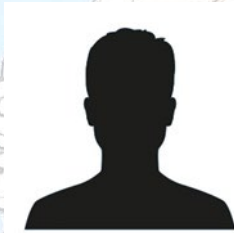
- Court appearance on June 18th
- Guilty plea
- Suspended sentence
- 12 months' Probation
- Do not contact/communicate with named party
- Do not attend within 50m of place of work or education
- Perform 20 hours of community service



Charges: Obstruct police, Possess property obtained by crime over \$5000, FTC Probation, Possession of a controlled substance; Meth & Cocaine

Disposition:

- Charges from STPS transferred to London court; this was a global sentence on 4 other informations from 3 other jurisdictions
- Guilty plea to Possess property obtained by crime over \$5000
- Sentenced to 18 months in jail (less 274 days PSC)
- Lifetime driving prohibition
- Remaining charges were withdrawn as part of the resolution



Charges: Impaired operation, Over 80 BAC

Disposition:

- Court appearance on June 21st
- Guilty plea to lesser offence of Careless driving
- \$1,000 fine
- 1 year Provincial Act Probation order
- Do not operate a m/v with a BAC above zero mgs
- Complete the Back on Track program
- Keep a copy of the probation order while operating a m/v
- Criminal code charges were withdrawn as part of the resolution
