**Charges:** Sexual interference, Invitation to sexual touching, Child pornography-accessing, Agreement/arrangement (electronic/inperson)- Sex offence against a child under 18, agreement/arrangement (electronic/in person)  
Sex offences against a child under 16.

**Disposition:**

Court appearance on July 17<sup>th</sup>  
Guilty plea to invitation to sexual touching, child pornography-accessing;

3 years jail

**Charges:** Failure or refusal to provide sample, fail to surrender permit , fail to have/surrender insurance card

**Disposition:**

Guilty plea to fail or refusal to provide sample  
Other charges withdrawn  
\$2,000 fine and 1 year driving prohibition



**Charges:** Impaired operation and possession of substance

**Disposition:**

Guilty plea to impaired operation by drug  
\$1,000 fine, 1 year driving prohibition  
Other charge withdrawn as part of resolution



**Charges:** FTC undertaking , FTC release x 3, Poss property, false pretenses x2, utter forged doc, obtain credit card by fraud, attempt/accessory to and Identity theft

**Disposition:**

Guilty plea to all  
6 months jail  
2 year non reporting Probation  
Do not attend named locations  
Do not communicate with named party
