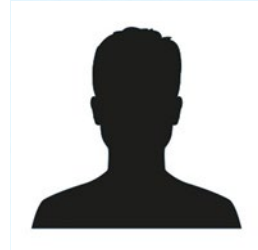

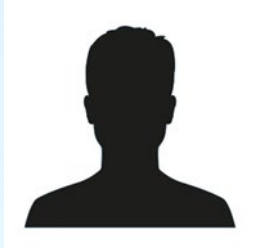

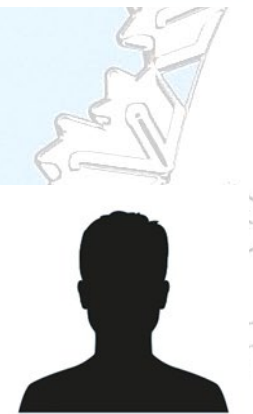

STPS - Theft under \$5000 x 6, FTC Probation x 5

Sentenced to 21 additional days (180 days less PSC = 106 days enhanced to 159)
2 years Probation
Do not attend named addresses
No weapons, no break and enter tools

Charges: Possess for the purpose of trafficking x 5, Possession of Property obtained by crime under \$5000 x 3, FTC release, Careless storage or a firearm & ammo, Unauthorized possession of a firearm, Knowledge of unauthorized possession of firearm, Possession of prohibited firearm, Occupant of m/v knowing there's a prohibited weapon

Disposition:
Court appearance on July 3, 2024
All criminal charges were withdrawn
CDSA charges were stayed by the Crown



Charges: Possess for the purpose of trafficking x 5, Possession of Property obtained by crime under \$5000 x 3, FTC release, Careless storage or a firearm & ammo, Unauthorized possession of a firearm, Knowledge of unauthorized possession of firearm, Possession of prohibited firearm, Occupant of m/v knowing there's a prohibited weapon, Poss of firearm/ammo contrary to prohibition order x 3

Charges: Utter death threat, FTC Probation x 3, FTC undertaking x 2

Disposition:
Court appearance on July 3, 2024
Guilty pleas; Utter death threat, FTC Probation & Release order
Sentenced to 150 days, 77 days PSC; 35 days left to serve
12 months' Probation
Do not be within 50m of any place the named party lives, works, attends school
Do not contact/communicate in any way direct/indirect with named party
Do not attend named address
Do not possess any weapons

Charges: Assault with a weapon, Utter death threat

Disposition:

Court appearance on July 3, 2024

Elgin Therapeutic Court – complete

Guilty plea to Utter death threat

12 months' Probation, usual conditions

Do not contact/communicate in any way with named party

Do not attend any place the named party lives, works or attends school

Do not be within 25m of named party

Do not possess any weapons

Perform 50 hours of community service



Charges: Indecent act, Mischief

Court appearance on July 3, 2024

ETC successfully court completed

Charges were Stayed
