**Form 11 Releases:**



**Charges:** Possess property under, Theft under x3, poss. for the purpose x 3 (fentanyl, meth), Operate while prohibited, FTC release order, Poss. property obtained by crime, poss. weapon without licence

**Released:**

Bail hearing on July 22nd  
Released on a Form 11  
Promise to pay \$5,000 if FTC with the release order  
Surety promised to pay \$5,000 if FTC with the release order  
Remain in custody until a GPS monitoring device is available  
Reside with sureties  
Remain in residence 24 hrs/day unless with at least 1 surety  
No contact with named parties  
Do not attend named locations  
Next court date Aug. 12<sup>th</sup>



**Charges:** Careless use of firearm, poss. purpose trafficking x2, poss. weapon for dangerous purpose, carry concealed weapon, unauthorized poss. firearm, unauthorized poss. firearm-knowing it's unauthorized, poss. property over, poss. property over proceeds of crime, Mischief under

**Released:**

Bail hearing July 24<sup>th</sup>. Decision given July 25<sup>th</sup>  
Released on Form 11  
Must pay \$2,500 if FTC with a condition of this order  
Reside with sureties  
Remain in residence 24hrs/day  
No contact with named party  
Do not attend named address  
Do not possess weapons  
Do not consume any drug under the CDSA  
Remain in custody until a GPS monitoring device is available  
Next court date Aug. 12<sup>th</sup>

**Charges:** Robbery with theft, Breach Probation x 2

**Released:**

Bail hearing July 26<sup>th</sup>  
Released on Form 11  
Promise to pay \$100 if fails to comply with any conditions of this order  
Do not communicate directly or indirectly by any means with named party  
Do not possess any weapons  
Next court date Aug 20<sup>th</sup>



**Charges:** Assault with a weapon, Threats with violence, B&E

**Released:**

Bail hearing July 22<sup>nd</sup>  
Released on Form 11  
Will pay \$5,000 if breach  
Reside with surety and remain in residence from 10 p – 7 a  
Do not communicate with all named parties  
Do not attend named addresses  
Remain outside St. Thomas

**Charge:** Breach Probation – curfew s. 137 YCJA

**Disposition:**

Court appearance on July 23<sup>rd</sup>  
Guilty plea to Breach. Other charges withdrawn  
27 days pre plea custody, one day deemed served



**Charge:** Assault, Breach Probation x 8

**Disposition:**

Court appearance on July 23<sup>rd</sup>  
Guilty plea to Assault and 2 Breach Probation charges  
Pre sentence custody enhanced to 90 days, one day deemed served  
Existing Probation Order still in effect

82 days pre plea custody enhanced to 123 days  
237 days left to serve  
3 years Probation

Do not attend named address  
Still has matters before the court on STPS charges
